The consequences of this dangerous action are grave on the courses of international events and destinies of peoples and nations and the future of the entire global order. Now the gigantic warplanes and the warships are shelling the cities and villages of Afghanistan and its mountains with rockets and bombs.

It will never stop at that extent. All indications and successive statements confirm that the Afghani dimension and the Taliban movement may be the small beginning or the little initial circle consisting, after throwing a stone in a lake, which was not still quietly, that will be followed by other circles and may not stop until the largest of which hits the land.

My mind was working with its full capacity in trying to arrive at convincing results. As much, the barrier of the unseen hid those results behind it as history events felt and investigated them. Such events were occurring successively in a bizarre hierarchy. The mosaics of those events make a quite clear picture of a dangerous ugly conspiracy, aiming at the

history, geography and future of a nation. The nation, which enriched human civilization, in its spirit, thought, won the heart of the world and supplied the western civilization with energy, without which the west cannot do, its march will stop and its strength will disappear.

I was driving slowly along the Cornish and a cool wind mixed with the sea smell striking my face. There were no other cars everything was calm. My mind got worried. Why not as long as the train of history never stops and nothing remains as it is.

I wished to have a quiet deep sleep, so went to my house. As every man in the world, especially in our Arab Islamic area, I was a captive of news information flowing day and night from rabid information media in following the successive accelerating events. I followed in particular, local political analysts, security experts, and their interpretations of various events occurring on the slopes of Hindu Koch Mountains, Afghani cities and American military deployment in Central Asia at the doors of China and in the heart of the vital area of Russia.

The whole matter was a huge enigma and a paradox difficult to understand by many. How can a group of young men think, scheme and execute an operation with such magnitude under the eyes and ears of the most powerful and efficient security forces? These forces possess technological means and technical, material and intelligence abilities, which qualify them to hear the sound of an ant's movement, watching the enemies in the snows of Siberia, the closed rooms of Moscow and inside the intestines of the terrible Chinese dragon.

How can a state like America define the murderer who attacked it heart in such accuracy after less than two hours of the event?

If the American Government represented by its security and political institutions knew that Ben Laden is its first enemy for years, how then it allowed his men to stay in America and have training courses for amateur in flying training planes? How could these amateurs fly civil planes of complicated equipments and systems with such a skill as recognized by aviation experts, then to crash them against New York towers and the Pentagon building in Washington? This only pilots of long experience who had flown thousands hours and

maneuvered such planes with perfection can do it. This is the opinion of aviation experts in the world and not my opinion.

Events continued to unfold and rhetoric had turned to saying the American militarism has an agenda in the Arab- Islamic region and it will not back out until it had exterminated the so-called terrorism, the term which was carefully prepared for years earlier as being the overwhelming danger and spreading cancer which must to be eradicated.

This very carefully marketed term , will ultimately be the Trojan horse and the legal and moral justification and the historical chance which was prepared fore very accurately to execute the dangerous phase of the grand conspiracy, which is run by the evils of Jewish Zionists and global masonry, who had taken Satan as their lord to worship instead of Allah . I have already displayed their schemes in the First part of this book, by quote from the wittings of the honest people in the Christian west who had said their word courageously. Najeh El- Maamori refers what was mentioned in the book "**Lord of Time**" by **Dr. Sayyed El- Qemni**," in his comments about the interview which the American journalist Robert Little with Shimon Perez about his book "The Future of Israel". (One of the few who managed to survive **Auschwitz Concentration Camp**, *the place in which Jews were tortured and burned in Poland*, a Jew named **Rudolf Feria** who said to the London Daily Herald in 1961, Yes I am a Jew and I accuse the Jews leaders of making the ugliest war

practices. That group knew in advance, what was waiting for their brothers in Nazi the gas chambers, among that group of leaders was **Castner** the Head of Jews Council in Hungary. When the scared Jews took the trains, their leaders told them that they are on their way to freedom, whereas they were driving them to execution.)

The Israeli daily the Voice of the People said in 1955(All people who the Germans killed one of their relatives in Hungary know now clearly that the Zionist leaderships had arranged for the crime with the Nazis.)

When the scandal escalated, they brought Castner before the court under pressure of public opinion to reveal facts. However, the Israeli daily Ydiout Ahranout wrote in 1955 "If Castner is trialed then the entire state will collapse politically and nationally due to what such a trial will reveal."

A short time before the start of the trial, Castner fell dead by shooting and it appeared later that Eckstein a Mossad agent had killed him.

The question was then:

Is it reasonable for the Zionist leadership to sacrifice such a huge number of Jews in a massacre?

The answer came first in establishing the state

Second in the testimony of **Coshe Chauliver**, **Castner's** assistance, who said calmly," The number of Hungarian Jews was great but they did not profess the any ideology. (Meaning they were not Zionists)

The leader of **Hagana** the reputed terrorist organization, Vigil Bulks met with **Ingman** in Cairo and expressed his satisfaction with the Jewish cooperation with the Nazis as planed for" (Future of Israel)

Therefore, the fingers of the Jews, their will and schemes are possibly present in the heart of 11 September events, knowing that the largest number of the Jews working in the two towers were absent on that day. This is a proven fact. However, no one can stir this matter because, of fear of accusing him, as a terrorist and anti Semitism.

THE MOSSAD

"Ha Mossad, le Modiyn Ve le Tafkaidim Mayuhadim"

The Heart of Evil and Satan's organization

The Mossad is the institute for intelligence and special; operations in Israel. If the Zionist Jews, through their- visible and invisible- huge influence are controlling the world now through their control of the influential and powerful international decision making institutions, the Mossad, through its approach and criminal thought is the right hand and the real Satan. It is in charge of tasks the purpose of which is to form and crystallize international policy and to direct it towards evil and destruction in the interests of the gelatinous satanic elite, which is controlling the world.

In order to be able to connect all the grand events, which shocked the world with the satanic evil forces, which the Mossad and its tributaries represent, I will display here the facts, which came out from their mouths documented with their references.

An ex- Mossad officer reveals the dangerous satanic force after he defected and escaped to Canada. He is **Victor Ostrovsky**, who says in the introduction of his book "**By Way of Deception**", (The Mossad, the intelligence force in charge of planning for the leaders who lead the nation, had betrayed this trust. It is scheming for its own benefit and for purposes serving its greed. It has put the nation on the way of clash and war with everything outside the state.)

What Mr. Ostrovsky had said explains clearly that the dangerous Mossad which many other organization support it such as **Global Masonry, PTAI, PRThP, AIPAC** and many others spread around the world. In addition to millions of Jews and the deceived spread in various parts of the world, who all work as collaborators or the so-called "**Sayanim**", who help the Mossad in realizing the satanic objectives of the Zionist elite. The same objectives as stated in the Protocols of the Elders of Zion to reach the grand social catastrophe, the eradication, destruction of all monotheist religions and control the lives all humans in the interest of Satan who had sworn before God to seduce people and lure them away from worshiping Allah the One Conqueror.

In displaying the above-mentioned facts by one of their folk, we can easily see those satanic fingers how close even involved in what had happened in New York and Washington.

In his book, "The Other Face of Deception" page 354, the ex-Zionist intelligence officer says, "On Wednesday 30 October 1991- Madrid-

'**Air Force 1**' was about to touch down. Then the second '**twin Air Force 1**' followed **it**. The two jumbo jets, which are identical in all but the call numbers inscribed on their fuselages (One carries the president and the second brings along the rest of the entourage. They use it as a backup in case of emergency). They were en route to **deliver the president of the United States and a large media contingent to the Madrid peace talks** that were about to start between Israel and all its Arab neighbors, including Syria and the Palestinians, who were part of the Jordanian delegation.

In the months leading up to this theatrical occasion, the American president had truly believed he would be able to bring about a change in the hardheaded attitudes that had prevailed in the region for decades. In an effort **to bring** the right-wing government of **Yitzhak Shamir to the negotiating table in what was to be an international peace conference, the president had applied** the kind of **pressure that an American president rarely has been brave enough to apply**. Against the wishes of an angry Jewish community, George Herbert Bush had put **a freeze on all loan guarantees to Israel**, which were to come to a total of ten billion dollars over the next five years. America by this freeze did not intend to punish Israel for the construction of settlements in the occupied West Bank and the Gaza Strip (regarded by the United States as illegal,) but to force the cash-strapped Likud government to the negotiating table.

Upon making that decision, **the President was instantly, placed on the blacklist of every Jewish organization in the United States**. They regarded him as the greatest enemy of the state of Israel. In Israel, posters depicting the president with a pharaoh's headgear and the inscription, we pasted across the country. Shamir called the president's action "**AmBush**."

Israeli messengers in all the communities across the United States immediately went into high gear, launching attacks against the president. They fed the media an endless stream of criticism, while trying at the same time to make it clear to Vice President Dan Quayle that he was still their sweetheart, that what the president was doing in no way affected their opinion of him.

This love affair with a vice president was not a new thing; it had been almost standard procedure ever since the creation of the state of Israel. **Any time a president was not on the best of terms with Israel; Israel instructed the Jewish organizations to cozy up to the vice president.** That was the case with Dwight Eisenhower, whom Israel regarded as the worst president in history (although, ironically, the vice president they regarded as a friend, namely Richard Nixon, himself became an enemy once he was president). It was what lay behind the strong support Israel and the Jewish community gave to Lyndon Johnson, who almost doubled aid to Israel in his first year as president, after **John Kennedy had come down hard on the Israeli nuclear program**, believing it was a first and dangerous step in the proliferation of nuclear weapons in the region.

That strategy was behind their hatred for Nixon and their admiration for Gerald Ford. Then there was Jimmy Carter, whose whole administration was regarded as a big mistake as far as Israel was concerned, a mistake that had cost Israel the whole of the Sinai in return for a lukewarm peace with Egypt.

Now there was this peace process, put forth by the country club idiot. The right-wingers' silent cry was to somehow stop the process, which they believed would lead to a compromise that would force Israel to return more land, refusing to believe that Israel would ever make such a compromise. **Settlers in the Occupied Territories had launched a new wave of construction, with the unrelenting help of Ariel Sharon, the minister of housing.**

A certain **right-wing clique in the Mossad regarded the crisis** and decided to take matters into their own hands, to solve the problem finally. They believed that Shamir would have ordered what they were about to do if he had not been gagged by politics. Like many others

before them, in countless countries and administrations, they were going to do what the leadership really wanted but could not ask for, while at the same time leaving the leadership out of the loop - they were going to become Israeli versions of Colonel Oliver North, only on a much more lethal level.

To this clique, it was clear what they must do. There was no doubt that Bush would be out of his element on October 30 when he arrived in **Madrid** to open the peace talks. This was going to be the most protected event of the year, with so many potential enemies meeting in one place. On top of that, there were all those who were against the talks: the Palestinian extremists, the Iranians, and the Libyans, not to mention the decimated Iraqis with their endless calls for revenge for the **Gulf War**.

The Spanish government had mobilized more than ten thousand police and civil guards. In addition, the American Secret Service, the Soviet KGB, and all the security services of all the countries involved would be on hand.

The Madrid Royal Palace would be the safest place on the planet at the time, unless you had the security plans and could find a flaw in them. That was exactly what the Mossad planned to do. It was clear from the start that **they would blame the Palestinians for the assassination** - perhaps ending, finally their irritating resistance and **making them the people most hated by all Americans**.

A **Kidon** unit took the three Palestinian extremists from their hiding place in Beirut and relocated incommunicado in a special detention location in the Negev desert. The three were **Beidhun Salameh, Mohammed Hussein, and Hussein Shahin**.

At the same time, there were various threats, some real and some not, against the president. **The Mossad clique added its share. In order to be more precise, it defined the threat as if it were coming from a group affiliated with none other than Abu Nidhal**. They knew that name carried with it a certain guarantee of getting attention and keeping it. So if something

were to happen, **the media would be quick to react and say, "We knew about it, and don't forget where you saw it first."**

Several days before the event, The **Mossad** leaked to the Spanish police that the three terrorists were on their way to Madrid and that they were probably planning some extravagant action. Since the Mossad had all the security arrangements, it would not be a problem for this particular clique to bring the "killers" as close as they might want to the president and then stage a killing. **In the ensuing confusion, the Mossad people would kill the "perpetrators,"** scoring yet another victory for the Mossad. They would be very sorry that they had not been able to save the president, but protecting him was not their job to begin with. With all the security forces involved and the assassins dead, it would be very difficult to discover where the security breach had been. Participating in the conference were several countries, regarded as assisting terrorists, such as Syria. With that in mind, **it would be a foregone conclusion where the breach was.**

As far as this Mossad clique was concerned, it was a win-win situation.

Ephraim called me on Tuesday, October 1. I could sense from the tone of his voice that he was feeling and extreme stress. **"They're out to kill Bush,"** he said. At first, I did not understand about what he was talking. I thought he meant that they were going to ruin the president. I had already heard of several books that were in the making on the man, and there was a smear campaign regarding his alleged involvement in the Iran-Contra affair (which I knew personally that it was a fake).

"What's new about that? They've been out to get him for a long time."

"I mean really kill, as in assassinate."

"What are you talking about? You cannot be serious. They would never dare do something like that."

"Don't go naive on me now," he said. "They're going to do it during the Madrid peace talks."

"Why don't you call the CIA and tell them? I mean, this isn't just some little operation you don't want to be involved in."

"I'll call whoever I have in the European intelligence services. I don't have friends in the American, not people I can trust, anyway."

"So what do you want me to do?"

"We are going to do what we can at our end. However, nothing we will do will become public. **I want you to make this thing public. If they know that the Americans know about it, there is a good chance they will not go ahead.**"

I knew that what he said was correct. If I could draw attention to it and make it public, that would do more to stop them than all the intelligence agencies put together. The trick would be to make it public without coming on like some lunatic with yet another conspiracy theory. I would have to say something in a relatively small forum and hope it would get out. If that did not work, I would contact some reporters I knew and give them the lowdown.

As it happened, I was a guest speaker at a luncheon held at the Parliament buildings in Ottawa for a group called the Middle East Discussion Group. It's a loosely formed think tank supported by the National Council on Canadian-Arab Relations, headed by a former Liberal MP named Ian Watson. The aim of this group is to inform members of Parliament and the diplomatic community on issues that media might not have free access to and to promote dialog on the Middle East.

Some twenty members of the think tank and a few MPs had attended the luncheon, I made a short presentation in which I explained the goals of the Mossad and the danger it presented to any peace initiative in the region. I also said that in my opinion, as things stood, **the only chance the Middle East had for peace would be the cutting off financial aid to Israel by the**

United States. I emphasized that a large chunk of this aid finds its way to the West Bank and the settlements, which were probably the biggest obstacle to the peace initiative. Then I opened the floor to questions.

They asked me what the **Mossad** would do to stop the process that was now taking place. I said that from sources, I had, and based on my knowledge of the **Mossad**, I would not be at all surprised if there was a plot right at this moment to kill the president of the United States and to throw the blame on some extreme Palestinian group.

Later, I learned that one of the people at the luncheon had called an ex-congressman from California, Pete McCloskey. The substance of what I had said was conveyed to him, and since **McCloskey** was an old and close friend of the president's, the caller felt that he might want to take some action.

On October 15, **McCloskey** called me and introduced himself. He said that he had heard from a friend what I had said about the president and wanted to know if in my opinion there was a real threat, or was this only a metaphor of some kind, to make a point. I made it clear to him that there was no metaphor involved and that I was dead serious regarding the threat to the president. I also said that I believed that exposing this threat might be enough to eliminate it, since to carry it out would then become too risky.

He said he could come to Ottawa within a few days and asked me if I would be willing to meet with him. I saw no reason why not, and we made an appointment for October 19, which was a weekend.

I met Pete at the Westin Hotel, and we walked over to a small coffee shop where we sat for several hours. He asked me questions from every possible angle, trying to understand about what I was talking. I could see that he was looking for information he could present that would make the threat realistic. There was no way I could tell him that I'd gotten the information straight from the horse's mouth, but I had to let him know that I was not completely

disconnected from the Mossad. That in itself was a risk; it was the first time I had allowed this to come out. I felt compelled, however, by the stakes involved.

The next day, Sunday, October 20, **McCloskey** was in Washington to participate in the meetings of the Commission on National and Community Services. He stayed at the Hotel Phoenix Park, from which he called the Secret Service at the White House. They referred him to Special Agent **Allan Dillon** at the Secret Service offices, 1050 Connecticut Avenue, N.W., Washington, D.C.

Pete faxed Dillon a copy of the memo he had written after our meeting in Ottawa. The same day, he met with a former White House aide from the Ford era, named Don Penny, who gave him the spin on me. I was not at all surprised when McCloskey told me later what Penny had told him: that he'd heard about me from Senator Sam Nunn and other sources in the CIA who said that I was a traitor to Israel and totally unreliable. In addition, that if McCloskey associated with me, he would be putting a target on his own back. As it turned out, Pete later spoke to Nunn, but the senator could not recall talking about me. Meanwhile, a well-known Washington columnist, Rowland Evans, told Pete that he had asked his sources in the CIA about me several months earlier, and they had told him that I was "for real."

McCloskey had an interview on October 22 with agent Terry Gallagher from the State Department Diplomatic Protection and then, the same day, a meeting with Dillon from the Secret Service. **On October 24, the Secret Service asked to speak to me.** They placed a formal request via the American embassy in Ottawa through CSIS (the Canadian security intelligence service), and I met with a member of the Secret Service in the presence of a member of CSIS.

I told the man what I thought was going to take place, only **omitting that I had obtained the information from an active member of the Mossad.** I did make it clear to him that I had a connection, which I mainly used to learn about impending personal danger.

The information leaked to the media, and in a syndicated column, Jack Anderson presented the whole story. So did Jane Hunter in her newsletter, which is necessary for any Washingtonian specializing in the Middle East.

I was confident that by now the president was no longer in imminent danger, although the less time he spent in Madrid, the better. However, they will not withdraw the decision to eliminate him; they would only postpone it. I had pointed out to the Secret Service agent, that the president was extremely vulnerable aboard Air Force 1, to attack by a surface-to-air missile and to a piece of explosive luggage that could be carried aboard by an unsuspecting re-porter who didn't realize that a segment of his recording or photographic equipment had been switched for a deadly device.

From Ephraim, I heard later that after the president had landed in Madrid, the American embassy there received a bomb threat on the phone, and they had evacuated a section of the embassy while the president was in the building. However, **they called off the rest of the plan** and even though the Spanish police received the names and descriptions of the three supposed assassins, they had not let them out of the holding facility in the Negev. Later, they had transferred them to the **Nes Ziyiyona** research facility, where they had terminated them. **Nes Ziyiyona** is a small town south of Tel Aviv, which houses the factories and laboratories of biological, chemical and nuclear weapons. The administration of those laboratories performs experiments on Arab Palestinian prisoners who they do not declare their arrest.)

That was the story of the Mossad officer **Victor Ostrovsky**, who defected, the dangerous criminal organization after he had discovered that it is carrying ambiguous criminal acts for serving the objectives of a supreme elite living in the dark, mastering the world and controlling the life of all peoples.

Is it not strange at least to the others, not for me personally, that this issue of attempting to assassinate the American President by the Mossad passes so smoothly without a fuss? No one of the officials or American security services or information media had moved to concentrate on this dangerous event. This shows the extent of influence, close relationship

and deep-rooted overlapping and unity of purpose between the institutions in Israel and America.

By displaying that story I intended to explain that the Mossad and its collaborators who are influential in the American Administrations – Particularly Bush's Administration- cannot be away from what had happened on 11 September. What confirmed this matter was the rhetoric of the American President Bush. He asserted that he wants to cease the '**Historic opportunity**' in order to sweep the Arab and Islamic worlds, to destroy their potentials and to impose hegemony in the name of fighting the so-called terrorism. Bush said that, in his speech before the Congress, to get its authorization to use force. For truths sake, the great American people and European peoples have taken superb stands by which they beautified the ugly face of the western civilization and its satanic spirit.

Victor Ostrovsky talks in his book '**The Other Face of Deception**' many events and facts with evidences that the Arabs were victims of this criminal organization, which was able through its cooperation with Global Masonry to perpetrate successive conspiracies to surround the Arabs and Muslims in the corner. Further, it was able, through deception, falsification of facts and legal and moral justifications to destroy Arabs and Muslims and to complete the attack of the satanic forces against them, in order to realize the objectives stated in the Protocols of the Elders of Zion.

SATANIC EXPERIMENTS IN (NES ZIYYONA)

Nes Ziyayona is a small town south of Tel Aviv, which ex- Mossad officer **Victor Ostrovsky** thought it was a center of investigation for the "**Shin Bet** ", "**Shabak**", or the Secret

internal Security Service in Israel. This conviction was before he became a Mossad member, when he was still a military police officer in the Israeli Army. After he had joined the **Mossad** as a professional intelligence officer, the facts, which were happening at Nes Ziyvona, began to reveal themselves before him as being one of the Secret world dens to which this officer belonged. Those facts were horrible and appalling. What was happening there was not only against humanity but also against human and spiritual values which man had experienced since the dawn of history until now, which chill the skins of even the fierce animals and human flesh eaters.

Ostrovsky says in his book "The Other Side of Deception" I his display of horrible events which he had lived, "I had met Yuri for the first time, when I was still in the military police in 1968- 1969. I was serving in the Jordan valley at a base called "**Jeftleq**" Which later became **Erick** after the officer name who the Palestinians killed while leading an intelligence team at the based. I was the military police commander at the base.

During those days, we carried out daily hot pursuits against infiltrating Palestinians across the borders. In most cases, we killed the Palestinians, but sometimes we caught them alive.

However, we used to announce their death by radio so as no one awaits their return.

My job was to take the Palestinian prisoners to a detention unit in **Nes Ziyvona**, which I used to think it was a **Shabak** investigation center.

We all knew that the prisoner who enters there is not likely to get out alive. However, the brainwashing convinced us that the issue is either they or we and there is no medial position or a grey area.

Yuri was the man who enlightened my mind about Nes Ziyvona unit, which was according to him a laboratory for "ABC" - atomic, biological and chemical experiments, where our scientists are developing various machines for Doomsday.

Because we were, weak and we did not have a second chance, the war was comprehensive, in which everything is used; therefore, we need this kind of weapons. There was no room for mistakes. In this respect, the infiltrating Palestinians were offering a big assistance. They were the human subjects for testing the weapons, which the scientists develop, to know

how effective they are. What terrifies me today by going back in my memory not what was going on but the calm and understanding by which I had accepted the affairs.

After years I met with Yuri, this time I were with the Mossad and he was a **Katsa** (a Mossad Caser- officer) or a senior officer in **Al Division** while I was still a beginner. He had just returned from South Africa and I was temporarily in **Dardasm Division** helping him to prepare in shipping a ship load of medicines to South Africa accompanied by a number of Israeli physicians sent to for human works in **Soweto**, which a city for the blacks outside **Johannesburg**.

The Israeli physicians were supposed to offer medical services in the outside clinic of **Baragwaneth Hospital** in Soweto, which was a few houses away from the house of **Whinny Mandela** and the house of bishop **Desmond Toto**. This hospital and its outside clinic were receiving support from a hospital in **Baltimore, which** provides a cover for the Mossad. Yuri was in period of freezing in the United States, so I asked him, "What does the Mossad do, offering human assistance and services to the blacks in (Soweto)? I was asking him and finding such work strange. There is no clear material gain in it. At the short term, it has no political gains, the most important motive for the Mossad operations. He answered me by asking, "Do you remember **Nes Ziyayona**?"

The questions stirred a shiver in my spine and I nodded.

Then, he said," it is like it. We test new medicines and new infections, which we cannot test them on humans in Israel.

I asked him, "What is your opinion about that?"

He answered," It is not my job to think about the subject."

Even if he had not said anything, I knew that he does not agree or at least I wished he were not happy about it.

We have completed the display of another aspect of the ugly satanic face of the establishment, which constitutes the Israeli political system. Its influence extends to cover the entire world including the United States of America, which cannot even reproach its dangerous practices and proven facts of espionage in the heart of America and inside its institutions

and sensitive security services. This situation stirs hundred questions and doubts about the privacy of that relation and its essence, extent and objectives.

All these matters are common knowledge and the events answer them quite clearly. However, the matter is not limited to this dimension only, but extends to include the international dimension, also. The fingers of the Mossad stir chaos and wars and execute assassinations wherever it sees there is an interest for it in doing so. For example I quote what had **Ostrovsky** written in his book, "By Way of Deception" about the Zionist role in India and Sri Lanka:

One of my tasks in mid July 1984 was to accompany a group of Indian nuclear scientists who were concerned about the Pakistani nuclear threat. They had come to Israel in a secret mission to meet wit Israeli nuclear scientists and exchange information with them. As appeared later the Israelis were happy to accept information from the Indians but they were hesitant in reciprocating in kind. On the day, the Indian group left Amy called me to his office in order to do two tasks.

The first was to prepare the tools and crew for a group of Israelis going to South Africa to train secret police units for that state. Then I have to go to an African Embassy to meet with a man who was supposed to return to his country, and to take him to **Hartselle**, accompany him to the airport and facilitate his passage through security gates. Amy told me, "I will meet you at the airport because we have a group from Sri Lanka coming to train here."

Amy was waiting for the arrival of the Sri Lankan plane when I joined him their. He told me when these people arrive do not pretend or say anything. I asked, "What do you mean?"

He said, "The beauty of those people is that they are like monkeys. They are coming from an unseen place. However, they are not as tall as trees. So, do not expect much from them."

Amy and I accompanied the nine **Sri Lankans** through the back door of the airport to an air-conditioned wing. They were the first arrivals of group, which will total nearly 50, which we will divide into three small groups.

Group (A) will be training on anti terrorist tactics at a military base near **Petah Tikva** called (**Kfar Sirkin**). They will get training on how to assault on hijacked planes and buses and

how to deal with kidnappers inside a building and on how to get down by a rope from a helicopter, and other anti-terrorist tactics. Of course, they will buy the so-called Uzis and other Israeli-made equipments including bulletproof jackets and special hand grenades, and so on.

Group (B) is a procuring team in Israel for weapons, they have bought seven or eight torpedo boats called **Devora**. They will use them mainly to guard their north shores against the **Tamils**.

Group (C) is a team of senior army officers to buy a radar system and other naval equipments to face the Tamils who continue crossing from India and planting mines in the Sri Lankan territorial waters.

My task was to accompany **Penny** the son wife of **Jayewardene** the Sri Lankan President, in a normal tourist tour for two days. Then someone else will take over this task. She was a kind woman and an Indian copy of **Corazon Aquino** physically. She turned to Buddhism because her husband is a Buddhist. However, she remained Christian, so she wanted to see all the holy Christian places. The next day I took her to "**Fred Ha Galilee**" or the "**Flower of Galilee**", which is a restaurant overlooking a superb scenery and serves very good food. A breeder of horses owns it. The **Mossad** had an open account in it.

Then, they ordered me to accompany the team of Sri Lankan senior army officers to the most favorable factory in **Ashdod** called "**Delta**" which can supply the required radar equipments. However, upon seeing their specifications the factory man said he would study the moves only and would not buy the required radar.

I asked him, "Why?"

He said, "These specifications are not the work of these monkeys. They are the work of a British radar maker named **Decca**

Therefore, these individuals know what they are going to buy. So give them bananas and send them to their country. Do not waste your time.

All this argument was in Hebrew while sitting and having tea, coffee and cakes.

Then he said the factory is in "Alta" and does not mind giving them a lecture, so that we do not seem turning down their request rudely.

Sympathy for the Tamils runs high in the southern Indian state of **Tamil Nadu**, where 40 million Tamils live. Many **Sri Lankan Tamils**, escaping the bloodshed, have sought refuge there, and the Sri Lankan government has accused Indian officials of arming and training the Tamils. However, they should be accusing the Mossad.

Yosy was supervising a group of Tamils the Israelis were training at the commando naval base, learning penetration techniques, mining landings, communications, and how to sabotage ships similar to the **Devora**. There were about 28 men in each group. The decision was that **Yosy** should take the Tamils to Haifa that night while I took the Sinhalese to Tel Aviv, thus avoiding any chance encounters.

The real problem started about two weeks into the courses, when both the Tamils and Sinhalese - unknown to each other, of course - were training at **Kfar Sirkin**. It is a large base, but even so, on one occasion the two groups passed within a few yards of each other while they were out jogging. After their basic training routine at **Kfar Sirkin**, they had taken **Sinhalese** to the naval base to teach them essentially, how to deal with all the techniques the Israelis had just taught the **Tamils**. It was hectic. We had to dream up punishments or night training exercises just to keep them busy, so that both groups would not be in **Tel Aviv** at the same time. The actions of this one man (Amy) could have jeopardized the political situation in Israel if these groups had met. I am sure Peres would not have slept at night if he had known this was going on. However, of course, he did not know.

When the three weeks were just about up and the **Sinhalese** were preparing to go to **Atlit**, the top-secret naval commando base, **Amy** told me he would not be going with them. The **Sayret Matcal** would take over their training. This was the top intelligence reconnaissance group. It is group, which carried out, the famous **Entebbe** raid in **Uganda**

"Look, we have a problem," said **Amy**. "We have a group of 27 SWAT team guys from **India** coming in."

"My God," I said, "What is this? We have **Sinhalese, Tamils**, and now **Indians**. Who's next?"

At the same time, I was meeting with a **Taiwanese** air force general named **Key**, the representative of their intelligence community in **Israel**. He worked out of the **Japanese** embassy, and he wanted to buy weapons. My orders were to show him around, but not to sell to him, since the Taiwanese would replicate in two days anything they bought, and end up competing with Israel on the market.

I had accompanied him to Sultan Factory in **Galilee**, in which we manufacture mortars, but factory owner told me that he could not sell him anything first because he was from Taiwan and second because all the manufactured mortars were sold in advance. I told him that I did not know that we were training in such a large scale on mortars, However the Iranians use a lot of them certainly. This keeps the factory working continuously. At a certain time, they made arrangements for the entrance a whole group of Taiwanese for training them.

It was a settlement of a bad type. They asked the **Mossad** to provide them with fighters in China instead doing it themselves. However, they trained a similar unit capable of collecting information from solid hot things.

There were Africans coming and going, and we provided them with various services. There were many fraud operations involving millions by which Israeli and Mossad officials had deceived African officials and others. Amy was one of them.

Through the talking of **Ostrovsky** and facts he had mentioned, the role of the Mossad becomes clear in instigating bloody conflicts in the entire world for serving its satanic purposes and realizing the supreme objectives of the evil scheme.

To make thing more evident, we will display two important incidents representing the type of crimes committed by this satanic organization to stir chaos, destruction and killing around the world.

The first incident is the conspiring with officials in South America to kill their opposing leaders inside the United States of America. The second incident is drug trafficking.

In the rainy morning of 21 September 1976 **Orlando Letelier** , 44 years old, left his house in the fine Embassies street in Washington. He was driving as usual an American blue car. Setting in the car beside the ex- Minister in Chili's Marxist government of Salvador Allende, was his unfortunate American friend researcher **Ronny Moffett**, who was twenty- five years old.

A few moments later, a bomb exploded by remote control shredding the car and all aboard it to tinny pieces. As happens in most cases of such cases, many people placed the responsibility on the American Central Agency "**CIA**", others pointed the secret police of Chili "**DINA**" which the new president **General Augusto Pinochet** dissolved the following year and it was reborn under a different authority. No one had referred to the **Mossad**. Although the **Mossad** was not directly involved in the hit and Chili's Secret Police- **DINA** -chief **Manuel Contreras Silveira** had ordered it, yet the **Mossad** had played an important role in the termination operation through a secret deal it had made with Manuel Contreras to buy the **Exocet**, a French-built anti-ship missile from Chili.

In August 1978, a grand federal court jury prosecuted **Manuel Contreras**, **Pedro Espinoza Bravo** the operations director of Chilean Secret Police and its agent **Armando Fernandez laryos**, four Cuban refugees who were members of a fanatic organization working against Castro inside the United States and an American borne agent called **Michael Vernon Townley**, who the Chilean Intelligence had recruited.

The Chilean president had categorically refused to hand **Manuel Contreras** his Intelligence chief to the American jurisdiction. So what was the story?

Israel wanted to obtain a French made missile called **Exocet**, particularly its head only. Since France was imposing an embargo on the sale of its arms to Israel at the time, so Israel thought of obtaining that missile. Thus, the **Mossad** had received the instructions to do so.

The Mossad had already gathered information about the **Exocet** through a Jewish volunteer, one of the so-called *Sayanim*- Jews residents of other countries who co-operate with the Mossad. This Jewish volunteer was working with French Aero-spatial Company, which manufactures the missile. This man had given information and details to the Mossad. The **Mossad** had carried a burglary operation and photographed all drawings and plans related to the missile. However all these were not enough. They must get the missile head in order to manufacture a copy of it in Israel.

There was only one chance for the Mossad , to get from Chili as the Chileans had already submitted a request to Israel to train their security services, Of course Israel has a black history in training most famous notorious oppressive security services such as **Iranian SAVAK**, Security Forces of Colombia, Argentine and Secret Police of Aide Amen of Uganda. Israel also had trained the secret police of the deposed Panama president Noriega, who used to pride himself by wearing the Uniform of Israeli Paratroopers. As we have already explained. Israelis had trained also forces of Sri Lankan Tamils and Sinhalese at the same time, in addition to Indians, who were all involved in a bloody civil war.

As **Pinochet** was interested in reforming his Secret Police Force, he had appointed **Manuel Contreras** as its chief and since **Contreras** had contacted Israel for this purpose, **Nagom Omony**, the **Mossad** chief later, asked the Mossad special branch for South America to do the job. The Mossad officers in Bolivia was called "**Amir**" was taking care of a factory, which **Shaul Eisenberg** the Israeli industrialist had built there.

In 1976 **Eisenberg** was the main element of a political scandal and police investigations in Canada after he had stolen the Canadian Loren Gray Ltd. At the time, no one knew where that

money went, which Eisenberg claimed he had spent in his role as an agent to the Canadian Atomic Energy Industry in an attempt to sell a nuclear reactor to South Korea.

The Mossad asked "**Amir**" to go to Santiago. Then he met his boss in New York, where the **Mossad** has many active intelligence networks. After **Amir** had submitted his report, his boss told him, "We want something from these men. Let us first suck them. Let us start with something and then submit our request. I mean we give the end of the rope and then we pull it."

The decision was **Amir** should go to Santiago again to meet with **Contreras** to inform him that Israel had agreed to train a group of 60 at the price of millions of dollars, which **Contreras** had accepted.

Shortly before the end of the training program, **Amir** went to Santiago to meet with **Contreras**. Thereafter **Amir** had assured his host of the results of the training program, he said to him directly, "We want something from you."

- What is it?

+ It is an **Exocet** missile head.

Contreras agreed but asked one million dollars for himself personally. Later he had got the amount and handed the missile to the Mossad inside Santiago. However, **Contreras** asked to meet with the **Mossad** chief. Therefore, **Nahum Admoni**, the Director of the Mossad from 1982 to 1989, went to Santiago immediately, where **Contreras** told him that he wanted to get rid of the opposition figures to **Pinochet government**, in the famous **Mossad style** of killing Arab and Palestinian politicians abroad. Israel had excelled in assassinations and killing of politicians and it used two ways:

First: the secret assassinations abroad to those who the **Mossad** thinks they are against the Israeli Zionist political approaches. A special assassination task force affiliated to the **Mossad**.

Second: the Public termination of Palestinians with rockets from warplanes and shells from tanks and other weaponry, in addition to kidnapping Palestinians from their homes and assassinating them.

Nahum Admoni had told **Contreras** that he has to report to his bosses in Tel Aviv because the matter requires a political decision by the Israeli government. Actually, Israel had chosen its most famous criminal **Michael "Mike" Harari** who directed the failed Lillehammer affair in Norway, in which a Moroccan waiter was killed who the Mossad miss-identified as the Palestinian leader **Ali Hassan Salameh**. Later Harari worked as a close advisor of **Noriega** the president of **Panama**. He returned to Israel just before or during the 1989 United States invasion of Panama. Harari was the most influential advisor to **Noriega**. He was also running in cooperation with the **Mossad** and the ruling circles in Israel a huge network for drug trafficking in the world and smuggling into United States of America.

Victor Ostrovsky said," The Israeli government wanted to avoid being directly involved in assassinations on behalf of **Contreras**, therefore it authorized **Michael "Mike" Harari** who was the owner of a big Israeli insurance company and the head of the **Mossad** department to which the assassination unit, the **Kidon** is affiliated. **Harari** had instructions to inform **Contreras** that he had taught his specialized counter terrorism unit everything and he had to get the approval of **Mossad** to teach it things the Mossad prefers to keep for itself. Further, the unit had learned enough to organize blow against their enemies abroad. DINA had paid the money for this training directly to Harari .This unit consisted of Contreras men and was not an official one.

On that wet day the 21 September 1976 in Washington when **Orlando Letelier** drove, his car for the last time, there was no idea that the assassin had his training at the hands of the **Mossad**. No one knew that Israel had the Exocet missile, also.

The Public and secret history of Israel which has been revealed so far proves that it is the State of Satan and its policy is based on killing, destruction, lying, deception and spying on friends and foes alike. It has theoretical and practical experience in the field of dangerous conspiracies and intrigues, such as the destruction of **World Trade Center** towers in New York and the Pentagon building in Washington D.C. This makes many in the world and even inside America not to exclude the fingers of Mossad in these dangerous terrorist operations, which heralded a major international political transformation, and the advent of the so-called war on **"Terrorism"**, a term that International Law experts have not agreed on a definition of its concept. The Zionist Satanic forces use this term now as a Trojan horse to achieve their evil objectives.

We have to mention, here the phrase "Historic Opportunity", which President Bush used in his speech before the Congress to get authorizing to use force. Indeed, he had used the huge American force to invade Iraq, to implement declared and undeclared policies against Islam, to destroy the potentials of the Arabs and Muslims and to dominate them in the name of fighting terrorism.

The term "historic Opportunity" which President Bush had asserted carries dangerous indications of the evil satanic scheme targeting our nation, in its past, its present and its future in particular. The obsession to invade and destroy Iraq, was the first step towards invading and dominating the rest of Arab and Islamic states and implement the decision of the satanic international group controlling the international decision.

Some people may find it strange that the rest of UN Security Council Permanent Member-states, which have the right of veto, exercise false political scenarios only to cover their sins because they inevitably accept and do not use the veto. The recent events, which occurred in the UN, prove clearly that UN is a mere cover for the strong states which they use it as legal justification to implement their schemes and ambitions, against other nations., which contradict them culturally, civilizationally and politically. As for the so-called international

law, it is a big illusion. It depicts a saying of Prophet Mohammad, "*If the strong steals, they leave him but if the weak steals, they punish him.*"

Behold the Arab children of Palestine, who America sees and knows for sure that the Israelis kill them everyday, not now only but since the birth of the little Satan from the womb of grand Satan. I here mention quote from a report for Swedish Children Fund, funded by Ford Foundation, issued in 1990. It charges Israel of using intensive violence and recurrent abuse against Palestinian children (Notice the use of the terms "**violence**" and "**abuse**" and not "**terrorism**"), About 50,000 to 65,000 children had treatment of injuries and at least 6,500 children killed or wounded by firearms rounds. Most killed children were not participating in stone throwing, at the time of shooting them. They had shot one-fifth of the examined cases in their either homes or 30 feet away from their homes.

Ostrovsky also says in epilogue of his book **By Way of Deception**, "This is the natural result after the laps of years and years of secrecy". He says also, "We are right and let us be right whatever happens" By misguiding the officials and justifying violence and inhumanness through deception or according to Mossad principle: By Way of Deception"

A STATE AGAINST GOD

(Yes, Israel is a state against God...

We wish the demise of the state of Israel would be painless)

The thin man in his priestly black cloak was talking with an obvious concern revealed by his disturbed voice tune. His hair locks were dangling on both sides of his face. His fine spectacles were vibrating on his nose due to his nervous movements while sitting in front of his interlocutor **Ahmed Mansour** in his program " **Bela Hudod**", which **Al Jazeera** unusually broadcasted several times. The man was quite honest in what he had said.

That man was **Rabbi Yisroel Dovid Weiss** spokesperson and religious leader of **Natori Karta**. The Jewish sect, which believes that the establishment of the State of Israel in Palestine is Against God's will, who had decreed that the Jews disperse in the earth and live in peace security within other nations and peoples which accept them in their midst. Further, this sect believes that the establishment of the state of Israel is contrary to the teaching of **Torah** and real **Jewish Shari'a** and it will cause the extermination of the Jews and the State of Israel itself. It also believes that the establishment of a Jewish State is a challenge to God's will and a following to Satan's orders.

The Rabbi had said several times frankly and clearly during that interview, "*Israel is a state against God and we wish its demise would be painless*". This means that the establishment of the Jewish State and gathering of the **Diaspora Jews** in it is the beginning mark of the imminent end. During that stage, the Jews will suffer comprehensive annihilation and destruction.

Asked about the Rabbis inside Israel who support its establishment and criminal practices, Rabbi Weiss said, "*Those paid Rabbis hired, know the truth but for the sake of their worldly interests and privileges had accepted to falsify religious facts and to follow the Zionists and to support their criminal project even against the Jews themselves as humans .*"

In order to be more acquainted with the Jews lying and falsification, since eternity, of historical and religious facts, we will display the seventh chapter of "**Illusions of Jewish History**" by **Jawdat Al- Saad, Publications of Al- Ahliyyah, Publishing and Distribution.**

The writer says, "*Judaism had never known integrated ideas and rites until after the Babylonian captivity 586 BC when writing began for the Torah, Biblical poetry, Structure of the religion framework, rites ideas approaches and objectives. The followers of prophet Moses had not formed clear frameworks.*" Of the so-called religion of pre -*Babylonian captivity*, we know only that they had worshipped "**Jehovah**" as stated in the **Torah** (Book of Numbers). However, evidences show they had taken the name of this "God" from the Canaanites Sinai. The common feature between Old **Egyptians**, **Babylonians** and **Phoenicians** were the animal sacrifices and some times human sacrifices.

It is no secret for any one that **Torah** (Book of Numbers) had pointed to worshiping a group of gods by the followers of Moses. These gods common in the region were **El**, **Baal**, **Jehovah** and **Elohim**. However, the concentration was on Jehovah who the Medians the dwellers of Sinai worshipped. So, why the concentration was in Jehovah, particularly?

The psychological conditions of captivity and the frustration, which this section of humans had felt, made them seek an emotional balance by resorting to a god characterized by cruelty, violence and might. Therefore, they had chosen this god as compensation. In fact, they had not worshipped Jehovah but borrowed while they were in **Babylon**.

The Babylonians used the term "Jew" or "Jews" for the first time in referring for those who they brought in captivity from "**Jehuda**", the Canaanite name for (**Urshalim- al-Quds,- Jerusalem**) area. This is an ancient tradition as well as contemporary. For example, the Iraqis call a man who had come from **Sham (Syria)** and settled among them "**Al- Shami**". The Palestinians call the man who had come from **Mesr (Egypt)** and settled among them "**Al- Mesri**" ... etc.

Sinhareb mentioned such a nicknaming (705 – 681 BC) while announcing his victories against **Jehuda**. He referred literally to " **a Jew**" he had brought from **Jehuda**.

The term "**Judaism**" did not appear during the first stages of writing the books of Torah. Thus the terms "**Jew**", "**Jews**" and "**Judaism**" appeared after the **Babylonian captivity**.

The talking about Judaism began after the 4th century BC. Judaism as we know it was formed in Babylon during the captivity (538- 330 BC) It matured semi- fully during the Greek and Roman era which is known by the phase of the "**Mocabiens**"

If the beginning of writing the Torah and putting its broad general lines were during the Babylonian state, therefore, they must have written many books of the Torah very late and during the **Saluki** rule era. They had written "**The Book of Denial**" and a group of **Psalms** during this era (168-165 BC). As for and "**The Book of Ayyub (Job)**" and "**The Book of Isaiah**" were written very late (100 BC). The Persian religion **Alzradaship** affected **Judaism** greatly. Thus, **Judaism** had taken the subjects of light and darkness gods controlling the world, as well as the existence of Satan and angels from Persia. The Dead Sea Scrolls indicate examples of such Persian effect. The acceptance of people of the Jews claims about their ancient history is due to Jews monopoly of recorded history for themselves. As Torah was the sole book, which combines all sciences of human heritage inside the ancient world: The **Sumerian, Babylonian, Assyrian Phoenician, Egyptian, Persian, Hythian and Greek**. They monopolized this entire heritage as if it were their own alone. Further, they added a sacred aura to this book that made the only secular and religious reference for most religious thoughts, which are prevailing in the world of today. This factor, in particular, hinders looking at the **Torah** objectively.

With the revealing of ancient world secrets, which accompanied deciphering of **Egyptian Hieroglyphic** and **Sumerian cuneiform** symbols and the rest of ancient languages, the extent of Torah quoting from heritage of the others became clear. It is so much that if you removed this heritage from the Torah it would become mere inkblots on paper. The writings rerecorded in the first five books of the Old Testimony are myths or news, which are impossible to prove their credibility. Therefore, it is difficult to place such information in a scientific historical framework. It is more useful to include them in the field of myth and fiction stories. They are generally lacking the evidence and the historical basis. Even the commandments, which some people think are the only remains of the true Torah, are extremely different from their original form.

The god '**Jehovah**' or '**Elohim**' in the Torah, which they had written, is completely devoid of divinity because they had characterized him with human descriptions. He concludes contracts with his chosen people, walks with them and serves them. He is excited emotionally in

happiness or wrath. These are all metaphoric traits taken from the religions of the ancient world, especially the traits ascribed to Babylonian gods. We mean by metaphoric traits ascribing to gods human spiritual and material traits, such as image, organs, thought, opinion and emotions in humans.

Jawdat Al- Saad gives two glaring examples of obvious stealing of the culture of others and including it in their religious myths. These are the glaring obvious similarity between **Aton anthem**, which the Egyptian used to worship, and the Psalms, which they had invented by stealing the texts of the **Aton anthem**.

In his book, "**The Illusions of Jewish History**" **Al- Saad** says, "The worship of **Aton** moved to **Palestine** by **Amenhotib 4th (Akhenaton)**. This worship may have moved to the **Mesopotamia** through the land of **Canaanites**. If we compare between **Aton's anthem** attributed to **Akhenaton** and some **Psalms** we see the quoting very clearly. As **Akhenaton** preceded the followers of Moses by 100 years, therefore the quoting must have been by the writers of the **Psalms**, who completed them, 800 years after Akhenaton.

In **Aton anthem**:

The sunrise is beautiful in the horizon, O Aton start life.

When you rise in the east, the horizon fills life with beauty.

Therefore, the art is beautiful, of great names and above the earth.

Your ray surrounds the universe and everything you had made. When you disappear, darkness will dam the horizon and the world, as if it were death.

Every lion comes out of its den, all snakes had taken darkness as their dwelling and the world is silent.

The Universe lights when you rise in the horizon and when you light the sun darkness disappears.

Thus, men perform their works

Ships sail up and down the river.

Fish jump in the sea as your light is in heart of the great sea.

In the *Psalms*:

Bless the LORD, O my soul. O LORD my God, thou art very great; thou art clothed with honor and majesty.

Who covers thyself with light as with a garment; that stretches out the heavens, like a curtain?

Who lays the beams of his chambers in the waters: who makes the clouds his chariot: who walks upon the wings of the wind?

Who makes his angels spirits; his ministers a flaming fire:

Who lay the foundations of the earth that it should remain forever.

Thou cover it with the deep as with a garment: the waters stood above the mountains.

At thy rebuke, they fled; at the voice of thy thunder, they hasted away.

They go up by the mountains; they go down by the valleys unto the place, which thou hast founded for them.

Thou hast set a bound that they may not pass over; that they turn not again to cover the ear
(Psalm 104:1 – 9)

He appointed the moon for seasons: the sun knows his going down.

Thou make darkness, and it is night: wherein all the beasts of the forest do creep forth.

The young lions roar after their prey, and seek their meat from God (Psalm 104:19, 20, & 21)

The sun arises, they gather themselves together, and lay them down in their dens.

Man goes forth unto his work and to his labor until the evening.

O LORD, how manifold are thy works! In wisdom, hast thou made them all, the earth is full of thy riches? (Psalm 104:22, 23 & 24)

Others went out on the sea in ships; they were merchants on the mighty waters.

They saw the works of the LORD, his wonderful deeds in the deep. (Psalm 107:23&24)

Many attempts had sought to discover "**The Book of Ayyub (Job)**" one of the possible ideas confirms the Egyptian influence and fingerprints of the Egyptian culture on this Book.

However, others see the land of Chaldeans is the birthplace of this Book. Yet, others say the Canaanites were the source from which the writers of this Book had quoted. Most likely one of the Jews, who had settled in Egypt during the Persian era after the birth of Judaism during the Babylonian captivity, wrote this Book there influenced by Babylonian, Assyrian, Canaanite and Egyptian cultures.

We note the following in "**The Book of Ayyub (Job)**" itself:

First mark of Egyptian influence we note is the mention of Uz, the country in which the Book says that Ayyub (Job) had lived. This country is nearer to Egypt than to land of the Chaldeans. It was at the Egyptian borders south of Edom (Ernie 25:19, 20)

Therefore, Uz is near **Egypt** not near **Mesopotamia**. There is a reference in **The Book of Ayyub (Job)**: *There was a man in the land of Uz, whose name was Job; and that man was perfect and upright, and one that feared God, and eschewed evil. In addition, there were born unto him seven sons and three daughters* (Job 1, 2&3) which refer that Uz was in the east, Palestine is west and not east of Mesopotamia. Therefore, Uz had to be east of Egypt. This fatal geographic mistake and confirms the Torah which they had written that **Job** had lived in **Ninawa** in Iraq.

Erman had discovered a written text in Aramaic in the area of **Fentine** which says, "*A deep sleep involving all people, a terrible fear befell me, I felt disturbed, my bones shivered, then a spirit passed in front of me, so my body hair stood upright. I woke up but I did not make sure of describing it, then it disappeared from my sight. The place was silent but I heard a voice.*"

This text coincides *entirely* with a text in the **Book of Ayyub (Job) (26:13- 16)**

The writer continues revealing the Jewish Quackery, theft and falsification. The Jews also had used lies about God to deceive people and mislead them for the sake of realizing their satanic dreams. He says, "Some writings on Papyrus, dating to 400BC were discovered, carrying the name '**Kegemni**' they include the wisdoms and conclusions which the writers of the Torah had borrowed and attributed to Prophet Solomon, May peace be upon him. A simple comparison will show the extent of quoting:

Every listener to my wisdom will be safe.

My blessings are for the seeker of truth and I will open the treasures of wisdom to him.

My wisdom takes a wide range from peace

Covenants are sharpened by knives and removed by leniency

If thou sit with a company of people, desire not the bread that thou like; short is the time of restraining the heart, and gluttony is an abomination;

The man who fills his belly is the one who usually cannot fill it in his house.

Be cautious about conflicts, man does not know when God's punishment comes.

In the **Biblical Proverbs:**

Give heed to my reproof; I will pour out my thoughts to you; I will make my words known to you
(1:23)

Blessings crown the head of the righteous, but violence overwhelms the mouth of the wicked.(10:6)

Bestowing wealth on those who love me and making their treasuries full.(8:21)

Wisdom has built her house; she has hewn out its seven pillars (9:1)

The LORD does not let the righteous go hungry but he thwarts the craving of the wicked

Lazy hands make a man poor, but diligent hands bring wealth. (10:3-4)

Do not associate with those who drink too much wine, with those who eat too much meat, because both a drunk and a glutton will become poor. Drowsiness will dress a person in rags.(23:20 ,21)

He who sows wickedness reaps trouble; and will destroy the rod of his fury. (22:8)

The rites of the Canaanite, Babylonian and Assyrian gods had leaked to the Judaism by virtue of its emergence in Babylon. We read also about worshiping the sun by the early Torah characters. They also called the **goddess Ishtar** its Babylonian name '**Queen of heaven**'. Babylon had affected the inhabitants of **Judah.**" *You are wearied in the multitude of your counsels; Let now the astrologers, the stargazers, and the monthly prognosticators Stand up and save you from what shall come upon you.*"(Isaiah 47:13)

Referring to the Torah (Book of Kings 2nd 17:30-31),"we find a number of gods worshipped in Mesopotamia were also worshipped by (the chosen people of God)," *And the men of Babylon made Succoth-benoth, and the men of Cuth made Nergal, and the men of Hamath made Ashima,*

And the Avites made Nibhaz and Tartak, and the Sepharvites burnt their children in fire to Adrammelech and Anammelech, the gods of Sepharvaim "

Researcher Castro Morris says," It is obvious that the Biblical thoughts had depended on Babylonian and Assyrian thoughts. By deep studies researcher of the Babylonian- Assyrian civilization find the images of the achievements mentioned in the Torah pale in comparison to those of Mesopotamia. This civilization will dominate any understanding of the biblical events. It enables us to study the thoughts of Judaism. It enables us also to have defensive positions in understanding the ambiguous characteristic of the entire Old Testimony. Torah had loaded to our history the mixing between superficial and basic elements to be the bases of the thoughts, which the old testimony had drawn, and underlined with false lights and deceptive ways. The Biblical researcher Joseph O Ford had written a lengthy comparison between many ideas mentioned in the cuneiform writings whether they were Sumerian or Acadian and those similar ones in the Torah. As the Sumerians and Acadians preceded Judaism and the writing of the

Torah by thousands of years, therefore it is logical that the writers of the Torah had taken their information and ideas from those who preceded them. When we have completed reading the available written scrolls in cuneiform and compared them with the text of the Torah, we found close links between these scrolls and what the Torah states. The religious names, which the Torah mentions, lead us to one source, which is natural in characteristics and human in appearance. Among the ideas, which the Torah had quoted for sure and found in many cuneiform yearbooks, are those, which deal with Allah as (a sponsor of his audience). Such as **Assur-re-sunu** meaning (Assur is their sponsor), and **Shamash –re ua** meaning (God Sun Sponsors me). Further, in the First Babylonian Dynasty many kings carried names of the previous meaning.

From this valuable information, it becomes quite clear that the Jews had written the text of the Old Testament or the so-called Torah, which is not the original one that Allah had inspired to Moses. They had renounced it and submitted to Satan and bloody desires and their instinctive hatred to humankind. They are instinctively inclined to evil in its worst forms. These traits the Qur'an had stated them in addition to what Allah had inspired in **Hadith of Prophet Mohammad:**

"Then woe to those who write the Book with their own hands and then say, "This is from Allah," to purchase with it a little price! Woe to them for what their hands have written and woe to them for that they earn thereby."(Al-Baqarah 79)

"O Children of Israel! Remember My Favor which I bestowed upon you, and fulfill (your obligations to) My Covenant (with you) so that I fulfill (My Obligations to) your covenant (with me), and fear none but Me.

Believe in what I have sent down (this Qur'an), confirming that which is with you, [the Taurat (Torah) and the Injeel (Gospel)]. Be not the first to disbelieve therein, and buy not with My Verses [the Taurat (Torah) and the Injeel (Gospel)] a small price and fear me and Me Alone.

Mix not truth with falsehood, nor conceal the truth [i.e. Muhammad Peace be upon him is Allah's Messenger and his qualities are written in your Scriptures, the Taurat (Torah) and the Injeel (Gospel)] while you know (the truth)." (Al-Baqarah 40, 41 &42)

"And they were covered with humiliation and misery, and they drew on themselves the Wrath of Allah. That was because they used to disbelieve the *Ayat* (proofs, evidences, verses, lessons, signs, revelations, etc.) of Allah and killed the Prophets wrongfully. That was because they disobeyed and used to transgress the bounds (in their disobedience to Allah, i.e. commit crimes and sins" (Al- Baqarah 61 partly)

"Then, after that, your hearts were hardened and became as stones or even worse in hardness. In addition, indeed, there are stones, out of which rivers gush forth, indeed, there are of them (stones) which split asunder so that water flows from them, and indeed, there are of them (stones) which fall down for fear of Allah, Neither Allah is unaware of what you do.

Do you (faithful believers) covet that they will believe in your religion in spite of the fact that a party of them (Jewish rabbis) used to hear the Word of Allah the Taurat (Torah)], then they used to change it knowingly after they had understood it." (Al-Baqarah 74 &75)

For altering Allah's words, their evil history of hatred for peoples of the world, their racism, cheap opportunism and their continuous efforts to control the potentials of humankind and their political powers, make the Jews a depiction of Satan worship . It reflects their distorted psychos, scheming evil towards all non-Jews humans. Jehovah, who they worship encourages them to shed blood by killing people, stabbing the bellies of pregnant women, burning cities and committing atrocities against their inhabitants, is undoubtedly Satan himself in his evilness and hatred towards all the great good values, which Allah's Prophets had brought, the last of who was Prophet Mohammad." **And, we have sent you (O Muhammad) not but as a mercy for the 'Alamin (mankind, jinns and all that exists). "(Al-Anbeya' 107)**

HEBREW AND - FLAGRANT QUACKERY

Moses was born in Egypt and he grew up under the sponsorship of its Royal dynasty. The Qur'an tells us about his story and his nation with the Pharaoh when he went to call him for the oneness of God and the Islamic religion which all Allah's prophets before our prophet Mohammad, the last of them , had called for . In the **Qur'an**, there is no mention that Moses had received the **Torah** in a language called **Hebrew**. The Jews had invented a language for themselves, after the laps of nearly 19 centuries, i.e. in the First century BC, immediately before the birth of **Christ**. However, historic discoveries had revealed their quackery even in the language, which they had invented and developed from the **Aramaic** language, which is originally a derivative of the **Phoenician** language. The known and proven fact historically and logically is that the language of Moses May peace be upon him, and his nation was the ancient Egyptian language. Further, the history researchers had proven- among them Jewish historians- the myths, the obvious mixing of history and the explicit lying in what they had written by their own hands and called The **Torah**.

In this regard, **Jawdat Al- Saad** says in his book "**Illusions of Jewish History**", "The Torah mixes illogically and joins incomprehensively two far separate eras of history. For example, it links the so-called the age of the **Patriarchs** (19th century BC) with the age of **Moses** and his followers(13th Century BC) and with the age of **Judaism** (5th century BC) and the following ages. It deals with all these three different ages as though they were the same time. Further, facts show that the so-called **Patriarchs** did not speak the ancient **Egyptian** language. In addition, when they settled in the lands of the **Canaanites** they spoke the Canaanite language.

Lying was their profession always, even to Allah. They had distorted and twisted the teaching of the true **Torah**, which Allah had inspired to **Moses**, may peace be upon him. They continued to lie, cheat and misguide humans for the sake of realizing the objectives of their idol **Satan** who had undertaken to seduce humankind and keep them away from worshipping **Allah** the one, the Just and from living in accordance with his *Sharia*, which **Allah** had ordained as a mercy for humankind.

THE MALIGNANT CONSPIRACY

(I know your rebellion and your hard hearts, after my death you will corrupt and deviate from the path I had recommended to you. Evil will affect you in the last days) **Moses** May peace be upon him.

The documents of the grand conspiracy appeared in 1784 when the Bavarian authorities revealed them to the world. However, they were able to resume the conspiracy after they had infiltrated and controlled the political and administrative bodies in western world, in particular. To achieve this they had used money, sex and extortion. They had also managed to divide the world into opposing and warring camps.

Karl Marks a German Jew who Germany and France had exiled him due to his destructive activities and England had granted him asylum. He founded **Communism**, which later became the ideology of one of the two super powers was that led the Eastern Camp in the cold war.

Karl Reiter a German professor who worked as teacher of geopolitics formulated an opposite theory, which says the Aryan race has the right to control Europe and the worlds. From his theory **Nazism** was born, and had led the world into the worst war in human history.

Further, the members of the criminal elite, who run the world movement from behind the curtains, were directly stirring the global struggle and supervising the implementation of those schemes, so they end up in pouring the resources and moneys of the world into their treasuries. Even **Karl**

Reiter himself had announced that either all men of finance in the world are Jews or of Jewish origin, if not then they are slaves to them through Masonry forums and commercial interests.

William Carr says in his book, "**Pawns on the Game**" that **Reiter** had advised the leaders of the **Aryan** race, after he had discussed the dangers which will result from their control of this handful (international Money -Barons) of the global policy and directing it according to their schemes. He submitted to them practical organized suggestions to fight the conspiracy of the international Money -Barons, who form the global invisible government from Jews. He drew a scheme for them to oppose it and after that to control the natural resource of the world in the interest of the Aryan race. Reiter had advised the leaders of the Aryan race to found Nazism and to use Fascism (National Socialism) as a means to realize their aspirations by sabotaging the schemes of the international Money -Barons and by invading the world.

Reiter had pointed in his scheme to the intention of the international Money -Barons to use Semitism in all aspects to realize their schemes. Therefore, the leaders of the Aryan race should use non-Semitism in all its aspects in order to proceed forward in the Aryan cause.

If we looked at a nation such as England, through the history documents and events which it had witnessed and what the Jews had done to it and its king and people, as another model of their criminality, we would be surprised how they managed to divide the English Christian society into factions.

In politics, they were able to recruit the English opposition leader **Oliver Cromwell**, when disputes erupted between **King Charles I** and the Parliament. **Manasseh Ben Israel** an agent of a global money baron in **Holland** had contacted **Cromwell Holland** and offered him huge amounts if he could execute their secret project, which aims at destabilizing monarchical system in Britain and dethroning the King. Senior Jewish global usurers in Germany and France were collaborating with **Manasseh Ben Israel** in supporting the conspiracy of executing the king after a long bloody civil war.

Then, the turn of the English people and the Church came. To achieve their objectives they introduced the **Calvinism** (after Calvin) by which, they managed to split the English people and their Church. Later it appeared that the real name of **Calvin** was **Cohen** and he changed when he moved from Switzerland to England.

William Carr says, at **B'nai B'rith Masons** celebrations held in Paris, France, in 1936 Cohen, or Calvin, was enthusiastically acclaimed to have been of Jewish descent.

It is useful here, to state the concrete evidence about **Cromwell's** collaboration with the Jewish international Money -Barons, who are scheming to destroy and control the world.

William Carr mentions the following:

Alfred Douglas, editor in chief of '**Plane English**' weekly had obtained the full evidence about the involvement of **Cromwell** in the Jewish global scheme. In an article in its issue of 3 September 1921, Lord Douglas explains how his friend in Amsterdam, **Van Valcalrt** had obtained the missing volume of the records of **Synagogue of Muljeim** . This volume was lost during the Napoleonic wars. It contains the records and letters, which the runners of this synagogue had received and answered, in German. Among them, one dated 6 June 1647, O.C. (Oliver Cromwell) wrote it to Rabbi **Ebenezer Pratt** in which he says, *“In return for financial support will advocate admission of Jews to England. This however impossible while Charles living. We cannot execute Charles without trial, adequate grounds for which do not exist. Therefore, I advise that Charles be assassinated, but will have nothing to do with arrangements for procuring an assassin, though willing to help in his escape.”*

In reply to this dispatch the records show **E. Pratt** wrote a letter dated July 12, 1647 addressed to **Oliver Cromwell**.

“Will grant financial aid as soon as Charles removed, and Jews admitted. Assassination is too dangerous. We should give Charles an opportunity to escape. His recapture will then make trial

and execution possible. The support will be liberal, but useless to discuss terms until trial commences."

Indeed, they had implemented the scheme accurately and they eradicated the members of parliament loyal to the king, who voted in favor holding an agreement with the king. Only 50 members of parliament, who supported Cromwell in holding absolute authority, remained alive after the eradication. Then they formed the Supreme Court from individuals in Cromwell's army. When they could not find a single English lawyer to act as the general prosecutor against the king, they brought a Jewish foreigner named **Dr Isaac Dorislaus**, who was an agent for **Manasseh Ben Israel** in England also.

The Jews or the international Money -Barons from the members of the global invisible government were able to control Britain politically and to make it fall into a an abyss of struggles and wars in order to restore their economic control

The most important events, which **William Carr** m mentions in his book "**Pawns in the Game**", are the following:

In 1649, Cromwell financed by Jews, waged war in Ireland.

In 1650, Montrose in rebellion against Cromwell, but was Captured and executed.

In 1651, Charles II, invaded England, but was defeated and fled back to France.

In 1652, England involved in war with Dutch.

In 1653, Cromwell proclaims himself *Lord Protector of England*.

In 1654, England involved in more wars.

In 1656, Trouble started in American Colonies.

In 1659, Richard, disgusted with intrigue, resigned.

In 1660, General Monk occupied London and Charles II proclaimed King.

In 1661, Truth revealed regarding intrigue entered into by Cromwell and his cohorts and, caused serious public reaction. They exhumed and hung bodies from gallows.

In 1662, they engendered religious strife to divide members of the Protestant denominations. They persecuted non-Conformists to the established Church of England.

In 1664, England was again involved in war with Holland.

In 1665, a great depression settled over England. Unemployment and shortages of food undermined the health of the people and the Great Plague broke out.^L

In 1666, England was involved in war with France and Holland.

In 1667, **Cabal** agents started a new religious and political strife. (The word Cabal is closely related to Cabala a mysterious Hebrew theosophy dating back into antiquity but which became very active during the 10th and succeeding centuries. Cabala was announced as “a special revelation” which enabled Rabbis to explain to the Jewish people the **hidden** meanings of the writings of **Holy Scripture.**” **Pear’s Cyclopedia** 57th edition, page 529 says, “Cabalism was later carried to great excess”. Cabal list leaders pretending to read signs, and evidence, in letters and forms, and numbers, contained in the Scriptures. The French named this mysterious rite Cabale. The French used the term Cabale to designate any group of political or private intriguers. The English coined the name Cabal because the chief personages concerned with Cabalistic intrigue in England were **Clifford Ashley, Buckingham, Arlington, and Lauderdale**, in that order. The first letter of their names spells Cabal!)

In 1674, England and Holland made Peace. The men directing international intrigue changed their characters. They became matchmakers. They elevated plain **Mr. William Straw Holder** to the rank of Captain-General of the Dutch Forces. He became **William Prince of Orange**. They arranged for him to meet Mary, the eldest daughter of the Duke of York, to remove him from becoming King of England.

In 1677, **Princess Mary** of England married **William Prince of Orange**. To place **William Prince of Orange** upon the Throne of England it was necessary to get rid of both **Charles II**, and the **Duke of York**, the stated to become **James II**.

In 1683, they hatched *the Rye House Plot*. The intention was to assassinate both King Charles II and the **Duke of York**. It failed.

In 1685, **King Charles II** died. The Duke of York became **King James II** of England. Immediately they started a campaign of defamation against **James II**. They persuaded or bribed the **Duke of Monmouth** into leading an insurrection to overthrow the king. On June In the **Battle of Sedgemoor** on 30 July, **Monmouth** was defeated, captured and executed. In August, **Judge Jeffrey** sentenced to death over 300 persons concerned in the **Monmouth Rebellion** under circumstances of atrocious cruelty. He condemned nearly one thousand others selling them as slaves.

This was a typical example of how the *Secret Powers*, working behind the scenes, create conditions for which to blame other people. Others are aroused to take active opposition against those they blame, who some others will liquidate in turn. King James still had to be disposed of before they could place **William of Orange** on the throne to carry out their mandate. Every person in England was bewitched and bewildered. They did not allow them to know the truth. People blamed everyone, and everything except the “Secret Powers” who were pulling the strings. Then the conspirators made their next move.

In 1688, they ordered **William Prince of Orange** to land in England at Torbay. This he did on November 5. King James abdicated. He fled to France. He had become unpopular because of the campaign of defamation and intrigue of the Barons of darkness.

In 1689, they proclaimed **William of Orange** and **Mary**, King and Queen of England. **King James** did not intend to give up the Throne without a fight. He was a **Catholic**, so the *Secret Powers* set up **William of Orange** as the Champion of the **Protestant Faith**. **King James** landed in Ireland where the Battle of the Boyne in which men of definite, and opposing, religious convictions fought.

(None of them knew that this battle was schemed by the secret powers (the global usurers) to realize their grand target of controlling England's economic resources and then its political potentials. Their first objective was to obtain permission to institute a Bank of England, consolidate, and secure the debts Britain owed them for loans made to her to fight the wars they instigated. History shows how they completed their plans.)

No sooner was the Dutch General sitting upon the throne of England than he persuaded the British Treasury to borrow £1,250,000 from the Jewish bankers who had put him there. The schoolbook history informs our children that the negotiations were between **Sir John Hamblen** and **Mr. William Patterson**, on behalf of the British Government with moneylenders, whose identity remained secret.

Search of historical documents reveals that in order to maintain complete secrecy they had carried on the negotiations regarding the terms of the loan, in a church. In the days of **Christ**, the moneylenders used the **Temple**. In the days of **William of Orange**, they desecrated a church.

The international moneylenders agreed to accommodate the British Treasury to the extent of £1,250,000 providing they could dictate their own terms and conditions.

The terms were in part:

The names of those, who made the loan, should remain secret. Further, to grant them a **Charter** to establish a Bank of England. The directors of the Bank of England, should be granted the legal right to establish the Gold Standard for currency, by which, they could make loans to the value of £10 for every £1 value of gold they had on deposit in their vaults. They have a permission, to consolidate the national debt; and secure payment of amounts due as principal and interest by direct taxation of the people.

Thus, for the sum of £1,250,000, **King William of Orange** sold the people of England into economic bondage. The Jewish moneylenders gained their ambitions. They had usurped the power to issue and control the currency of the nation. Having secured that power, they cared not who made the laws.

Just what the acceptance of the **Gold Standard** meant we could best illustrate it by citing a simple transaction. — The directors of the Bank of England could loan £1,000 for every £100 worth of

gold they had on deposit as security. They collected interest on the full £1,000 loan. At 5 per cent, this amounted to £50 a year. Therefore, at the end of the first year the bankers collected back 50 per cent of the amount they had originally put up to secure the loan. If a private individual wished to obtain a loan, the bankers made him put up security, in the form of property, stocks, or bonds, much in excess of the value of the loan he required. If he failed to meet payments of principal and interest, they would take foreclosure proceedings against his property, and the moneylenders obtained many times the value of the loan.

The international bankers never intended that England manage to pay off the national indebtedness. The plan was to create international conditions, which would plunge all nations concerned deeper and deeper into their debt.

As far as England is concerned, in only four years, 1694 to 1698, the national debt had increased from one to sixteen million pounds sterling. This debt accumulated because of wars. It is interesting to note that **John Churchill**, 1650-1722, became the leading military figure during this period of English history. Because of his military genius, and his services to Britain, they acclaimed him the first **Duke of Marlborough** (By the duke is the direct ancestor of **Sir Winston Churchill**, the **Prime Minister of England** in 1954 who was self-acknowledged as having been the foremost **Zionist** of that era. He is the man most responsible for influencing the United Nations to create the State of Israel.)

The Secret Power behind the World Revolutionary Movement pulled the necessary strings and brought about *The Wars of the Spanish Succession*. In 1701, they made the **Duke of Marlborough** Commander-in-chief of the armed forces of Holland. No less an authority than the **Jewish Encyclopedia** records the fact that for his many services the **Duke of Marlborough** received not less than £6,000 a year from the **Dutch Jewish** banker, **Solomon Medina**.

The events leading up to the **French Revolution** show how between 1698 and 1815 the **National Debt of Britain** had increased to £885,000,000. By 1945, the **British National Debt** had reached

the astronomical figure of £22,503,532,372, and for the years 1945-46, the carrying charges alone amounted to £445,446,241.

Evidence will now be produced to identify some of these **International Jewish moneylenders** and prove they, or their successors, plotted and planned, and helped finance, the Great French Revolution of 1789, exactly the same way as they had plotted and planned and financed the English Revolution of 1640-1649

They have contacted the **Marquis of Mirabeau** as the most likely person in France to serve their ends. He belonged to the nobility. He had great influence in court circles, he was an intimate friend of the **Duke of Orleans** whom they had decided they would use as a *Front Man* to lead the **French Revolution**. However, more important still, the **Marquis of Mirabeau** was devoid of morals and his licentious excesses had led him heavily into debt.

It was a simple matter for the moneylenders to have their agents contact **Mirabeau**, the famous **French orator**. Under the guise of friends and admirers, they offered to help him out of his financial difficulties. What they actually did was lead him down the “Primrose Path” into the very depths of vice and debauchery until he was so deeply in their debt that they could force him to do their bidding. At a meeting to consolidate his debts, they introduced **Mirabeau** to **Moses Mendelssohn**, one of the big Jewish financiers who took him in hand. **Mendelssohn** in due time introduced **Mirabeau** to a woman, famous for her personal beauty and charm but without moral scruples.

This stunning **Jewess** was married to a man named **Herz**, but, to a man like **Mirabeau**, the fact that she was married only made her more desirable. It was not long before she was spending more time with **Mirabeau** than she was spending with her husband. Heavily in debt to **Mendelssohn**, tightly ensnared by **Mrs. Herz**, **Mirabeau** was completely helpless ... He had swallowed their bait. However, like good fishers, they played him gently for a time. If they exerted too great a pressure the leader might break and their fish might get away. Their next move was to have him initiated

into **Illuminatism**. He was sworn to secrecy and unlimited obedience under pain of death. The next move was to lead him into compromising situations, which mysteriously became public. They called this method of destroying a man's character as the practice of *Defamation*. Because of scandals and organized detraction, many of **Mirabeau's** social equals ostracized him. His resentment produced a desire for revenge and thus he embraced the revolutionary *Cause*.

Mirabeau's task was to induce the **Duke of Orleans** to lead the **Revolutionary Movement** in France. The implication was that once they manage too force the King to abdicate he would become the **Democratic Ruler of France**. The real plotters of the **French Revolution** were careful not to let either **Mirabeau** or the **Duke of Orleans** know they intended to murder the **King and Queen**, and thousands of the nobility

The conspiracy did not stop at France. The same thing happened in Turkey, Russia and Germany and the rest of States in Europe. Then the turn came for America, where they had managed to infiltrate into the financial, economic and information systems in order to control the largest economic and military power in the world.

Now, they are actually controlling financial and informational establishments. They have always managed to get their men and members of their Masonry forums to the realm of power, where they make politicians by two main methods: money and information. A member of Congress costs not less than ten million dollars, However to get to the presidency of the state, costs hundreds of millions dollars. This of course in addition to publicly polishing through their information media, by, which they could easily turn, lies into truths and vice versa. They make politicians and stars in the same melting pit.

Benjamin Franklin did not deviate from truth when he cautioned in his speech on formulating the constitution of the United State of America in 1798 from the entrance of Jews into America. He even demanded that putting a provision in the constitution, which prohibits the entrance of Jews into USA. He had predicted what is happening today in a very astonishing way.

We point out that the events, which occurred in New York and Washington, were the result of the secret fingers of the **Jews** and the **Illuminati** as they were in all stages. Further, even the implementation and the perpetrators of this crime, which has become a Trojan horse or the historic justification or chance as George W Bush had declared it in his speech to the Congress to get authorized to carry out dangerous military schemes to strike and destroy Arab and Islamic peoples under the pretext of fighting terrorism. Those declared targets about terrorism, however, are just a curtain canceling other motives, which those of aware minds of the dangerous history of the Jews and the **Illuminati** can feel. The aim is of course to dominate the Arab and Islamic peoples and their potentials and resources to implement the final episodes of this evil play and the series of satanic aspirations.

It may be useful here to display quickly how they infiltrated into the joints of the American economy and controlling it, by the Jews. This enabled them to control The American political decision- making institutions, being the makers of political leaderships, which run those institutions. What we say here is quoting from William Guy Carr's book, **Pawns in the Game** upon which we rely in addition to other sources of reference. He says:

In order to understand, how men who obtained control of the Bank of England, and the British National Debt obtained control of the trade and commerce, and the monetary system of Britain's American colonies, it will be sufficient if we pick up the threads of the story at the time. **Benjamin Franklin** (1706-1790) went over to England to represent the interests of the men who had been associated with him in building up the prosperity of the American Colonies.

Robert L. Owen, former chairperson, Committee on Banking and Currency, United States Senate, explains the matter on page 98 of Senate Document No. 23. He states that when associates of the **Rothschild's** asked **Franklin** how he accounted for the prosperous conditions prevailing in the colonies, he replied, "That is simple — In the Colonies we issue our own money. It is called Colonial Script — we issue it in proper proportion to the demands of trade and industry."

Robert L. Owen remarked that not very long after the **Rothschild's** (the Jewish group of international moneylender's money barons, the members of the global satanic invisible government of the **Illuminati**) heard of this they realized the opportunity to exploit the situation with considerable profit to them. The obvious thing to do was to have a law passed prohibiting the Colonial officials from issuing their own money and make it compulsory for them to obtain the money they required through the medium of the Banks. **Amschel Mayer Rothschild** was still in Germany but he was supplying the British Government with Mercenary Troops at £8 per man. Such was his influence that in 1764 he succeeded, through the Directors of the Bank of England, in having laws passed in accordance with his dictates.

The authorities in the Colonies had to discard their Script money. They had to mortgage the Colonial assets and securities to the Bank of England in order to borrow the money they needed to carry on business.

Referring to those facts Benjamin Franklin stated. "In one year the conditions were so reversed that the era of prosperity ended, and a depression set in, to such an extent that the streets of the Colonies were filled with unemployed."

Franklin stated, "The Bank of England refused to give more than 50 per cent of the face value of the *Script* when turned over as required by law. The circulating medium of exchange was thus reduced by half".

Some historians and researchers say the cause of the American Revolution was the famous Tea Taxes. However, **Franklin** who was one of the prominent faces of that revolution, had disclosed the primary cause of the Revolution by saying, "The Colonies would gladly have borne the little tax on tea and other matters had it not been that England took away from the Colonies their money, which created unemployment and dissatisfaction."

Dissatisfaction became general, but very few Colonials realized that the taxation and other economic sanctions imposed on them, resulted from the activities of a small group of International

Gangsters, who had succeeded in obtaining control of the British Treasury, after they had obtained control of the Bank of England. We have already shown how they jumped Britain's National Debt from £1,250,000 in 1694 to £16,000,000 in 1698, and increased it progressively to £885,000,000 by 1815, and £22,503,532,372 by 1945.

On 19 April 1775, the first armed clashes between British and Colonials took place at Lexington and Concord.

On 10 May, the Second Continental Congress met at Philadelphia and **George Washington** proclaimed the head of the Naval and Military Force. .

On 4 July 1776, Congress adopted the Declaration of Independence. For the next seven years, the International moneylenders urged and financed the Colonial War. The **Rothschild's** had made plenty of money supplying the British with German Hessian mercenary soldiers with which to fight the Colonists. The average British had no quarrel with his American cousins. He secretly sympathized with them.

On 19 October 1781, the British Commander, General Cornwallis, surrendered his whole army, including what was left of the Hessians. However, the agents of the international bankers worked industriously to prevent unity. By keeping the various states in America separated, it was much easier to exploit them. To prove the continuity of the foreign moneylenders meddling in the affairs of every nation it is sufficient to record that *the Foundling Fathers of the United States* meeting at Philadelphia in 1787 talked over the importance of bringing in some form of legislation that would protect them against the exploitation of the International Bankers.

The agents of the international bankers organized active lobbying. They used intimidation. But despite all their efforts paragraph 5, of Section 8, of the First article of the new American Constitution read: “**CONGRESS SHALL HAVE THE POWER TO COIN MONEY AND REGULATE THE VALUE THEREOF**”.

. The fact that subsequent legislation dealing with finance and currency, have been in violation of the provisions laid down in Article 1, Section 8, paragraph 5, proves how powerful the bankers have been in the political field.

Using the good old reliable Joint Stock Company principle, the Directors of the Bank of England appointed one of their hirelings named **Alexander Hamilton**, to represent their interests in the United States. This man, a supposed patriot, proposed the establishment of a **Federal Bank**, owned by **PRIVATE INTERESTS**.

It was an alternative proposal to those who insisted the issue and control of money should remain in the hands of the government elected by the people. Alexander Hamilton suggested that his proposed to capitalize Federal Bank for \$12,000,000. The Bank of England would provide \$10,000,000; wealthy people in America would provide the remaining \$2,000,000

In 1783 **Alexander Hamilton**, and his business partner **Robert Morris**, organized the **Bank of America**.

As Financial Superintendent of the Continental Congress, Morris was able to reduce the United States Treasury to a state of indigence by the end of seven years of war. This is another illustration of how the *Secret Power* use wars to further their plan for the W.R.M. To make sure the United States' Financial cupboard was bare. Hamilton transferred the last \$250,000 from the Treasury Department, and invested it in the Bank's Capital Stock. The directors of the Bank of America were agents of the Bank of England. The Illuminati controlled both. The fact that they sold their souls to Satan in order to gain the world is the truth they wish to conceal.

The Fathers of American Independence realized that if the Directors of the Bank of England obtained monopolistic control of America's money system they would recover any money they had lost by the simple process of mortgage and foreclosure. The net result of this struggle for economic control of the nation was that Congress refused to grant the Bank of America a charter.

Benjamin Franklin died in 1790 and the agents of the International Jewish moneylenders immediately made another bid to obtain control of America's finances. They succeeded in having Alexander Hamilton appointed Secretary of the Treasury. Hamilton had the Government charter the bank his principals had been clamoring. It was then a simple matter to usurp the rights to issue currency based on public and private debts. The most forceful arguments the bankers' agents had used to defeat their opposition was that money issued by Congress, on the credit of the Nation, would be valueless in dealing abroad; while money obtained on loan from the bankers, at interest, would be welcomed as legal security in all kinds of transactions.

Thus, the public were prey to the exploitation of the men who professed their friends. Alexander Hamilton and Morris were never mere hirelings of the international moneylenders. The international bankers decided that Hamilton knew too much and could not be trusted any longer. They inveigled him into a duel with an expert named **Aaron Burr**, who acted as his executioner.

While the international bankers used American citizens as Front men, policy was determined in Europe. The Rothschild interests gave orders that the American bankers were to extend almost unlimited credit for good security and put plenty of money into circulation. The propaganda media played up on the highest notes of optimism. They assured Prosperity. The Americans were destined to become the greatest people on Earth. They urged everybody to invest in the future of his great nation.

When every one of any worth had mortgaged himself to the hilt, the **Rothschild's** ordered to tighten up credits, recall outstanding loans, and reduce the amount of money in circulation. Thus, they created an artificial depression. Citizens could not meet their financial obligations and the Money Barons obtained millions of dollars worth of property, and securities, at a fraction of their normal value. Admittedly, they had done everything by due process of law, but **Al Capone** and his gangsters, were gentle men in comparison with these international bankers.

Many great Americans have commented on this phase of the history of the United States, but their expressed opinions do not seem to have prevented their successors from falling into the same traps

and pit-falls. **John Adams** wrote a letter to **Thomas Jefferson**, in which he said, “All the perplexities, confusion and distress arise not from the defects of the **Constitution**, not from want of honor and virtue so much as, from downright ignorance of the nature of coin, credit and circulation.”

Thomas Jefferson in his reply said, “I believe that banking institutions are more dangerous to our liberties than standing armies. Already they have raised a money aristocracy that has set governments at defiance. The issuing power should be taken from the banks and restored to the people to whom it properly belongs”.

Andrew Jackson said, “If **Congress** has a right, under the **Constitution** to issue paper money, it was given them to use by themselves, not to be delegated to individuals or corporations.”

These outspoken comments warned the **International Bankers** to expect serious opposition when their Charter for the Bank of the United States ran out in 1811. To prepare for this eventuality, **Amschel Mayer Rothschild** had obtained absolute control of the **Bank of England** in order to strengthen his control of the World’s economy. He trained his son **Nathan** specially to undertake this tremendous task as previously mentioned. Nathan proved to have exceptional talent and ability for financial affairs. He trained himself only to think in terms of profits, just as the professional politician thinks only in terms of votes.

In 1798, at the early age of twenty-one, he went over from Germany to secure control of the Bank of England. They entrusted him with the modest sum of £20,000. To demonstrate his financial wizardry he speculated, and in a comparatively short time [3 years], he increased his capital to £60,000. By 1811, when the matter of the renewal of the Charter for the Bank of America was due for a hearing, **Nathan Rothschild** was in control of the International Bankers. He issued the following ultimatum:

“Either the application for renewal of the charter is granted or the United States will find itself involved in a most disastrous war.”

The **Americans** did not believe the **International Bankers** would foment a war. **President Andrew Jackson** decided to call their bluff. He told them bluntly: “You are a den of thieves — vipers. I intend to rout you out, and by the Eternal God, I will rout you out.

However, **President Andrew Jackson** had underestimated the power of the **Rothschild's**. **Nathan Rothschild** issued orders. “Teach these impudent **Americans** a lesson. Bring them back to Colonial status.”

The British Government, always subservient to the Bank of England, launched the war of 1812. They calculated for this war to impoverish the United States to such an extent the legislators would have to plead for peace, and seek financial aid. **Nathan Rothschild** stipulated that no financial aid would be forthcoming except in return for the renewal of the charter for the Bank of America.

Nathan Rothschild's plan worked to perfection. It mattered not to him, the number of killed and wounded men; widowed women, orphaned children or impoverished people. He and his co-conspirators rejoiced in the fact that they had achieved their objective and in so doing they had created more and more dissatisfaction amongst the masses of the people who blamed the blundering policies of their own governments, while the *Secret Power* behind the scenes remained unsuspected by all except a very few people.

In 1816, The **United States Congress** granted the renewal of the **Charter for the Bank of the United States** as requested. There are many authorities who state frankly that the **Members of Congress**, were bribed or threatened, into voting for the legislation that put the American people back into financial bondage.

The men who plot and plan to secure economic and political control of the world do not hesitate to prostitute *Love* to achieve their ends, any more than they hesitate to order murder committed to rid them of men who stand in their way. (*By the way, Senator Wellstone, who vehemently opposed Bush's war on Iraq, died in a plane crash*).

In 1857, the marriage of Lenora, daughter of **Lionel Rothschild**, to her cousin **Alfonso** of Paris (they believe in keeping things within the family) brought many international personages to London, England, where they performed the ceremony. They had invited **Benjamin Disraeli**, the noted English Statesman, who they made Prime Minister in 1868 and again in 1874, to be present.

Disraeli said during his speech on that memorable occasion, “Under this roof are the heads of the family of Rothschild, a name famous in every capital of Europe, and every division of the globe. If you like, we shall divide the United States into two parts, one for you James, and one for you Lionel. **Napoleon III** will do exactly — and all that I advise him to do; and to **Bismarck** will be suggested such an intoxicating program as to make him our abject slave.”

History records how they appointed **Judah P. Benjamin**, a **Rothschild** relative, as their professional strategist in America. The **American Civil War**, which split the Union in two, became an accomplished fact.

The Bankers persuaded Napoleon III to extend his French Empire into Mexico. They persuaded British Government that they could make the Northern States into a colony again.

The **Civil War** in the **United States** was an economic war brought about by the **International Bankers**. By applying economic pressure, it was a simple matter to aggravate the economic difficulties, which the Northern States encountered after granting the slaves their freedom. Abraham Lincoln admitted, “No nation can long endure half free and half slaves.”

The international bankers loaned unlimited credit to all forces engaged by the South fighting the forces of the North. They loaned **Napoleon III**, 201,500,000 francs to finance his **Mexican** campaign. When the Confederacy needed assistance in 1863, the Powers-that-be offered **Napoleon Texas** and **Louisiana** in exchange for French intervention against the **Northern States**.

The Tsar of Russia heard of these preposterous offers and he informed the Governments of **England** and **France** that should they actively intervene, and give military aid to the **South**, **Russia** would consider such action as a declaration of war against the **Imperial Russian Empire**. To

strengthen his ultimatum he sent **Russian warships** to **New York** and **San Francisco** and placed them at **Lincoln's** disposal. (*This act of interference caused the International Bankers decide to overthrow the Russian Government, Later by creating the idea of Communism*)

When the Northern authorities found themselves in financial difficulties, the International Bankers did not refuse to loan them money. They simply stipulated that the rate of interest to the Northern States would be 28 per cent. After all, they were in business as moneylenders. An important aspect of the **American Civil War** is that it would in all probability have reached a conclusion in a few months had not the international moneylenders made fresh loans. These loans were usury. They based the loans on terms and rates of interest, which they calculated them to give international bankers, control of the economy of the whole country. When they considered it time, they ended the war.

Lincoln tried to break the financial bonds with which the International Bankers bound his Northern States. To him Article 1, Section 8, paragraph 5 of the Constitution was sufficient authority. He disregarded the bankers' overtures. He caused \$450,000,000 of *honest* money to be printed. He placed the *Credit of the Nation* as security behind this money. The International Bankers retaliated by causing a Bill to be passed through Congress ruling that *Lincoln's Greenbacks* would not be accepted as payment of interest on government bonds nor import duties. The Bankers caused Lincoln's money to become almost valueless by refusing to accept the *Greenbacks* except at a heavy discount. Having beaten down the value of Greenback dollars to 30 cents they bought them all. They then turned around and bought government bonds with them demanding dollar for dollar value. In this way, they overcame a serious threat and made 70 cents on the dollar.

An article, inspired by the **International Bankers**, appeared in the *London Times*. It concerned **Abraham Lincoln's issue of Greenbacks**. It said, "If this mischievous financial policy, which has its origin in **North America**, shall become indurate down to a fixture, then that Government will furnish its own money without cost. It will pay off debts and be without debt. It will have all the money necessary to carry on its commerce. It will become prosperous without precedent in the history of the world. The brains and wealth of all countries will go to North America. THAT

COUNTRY MUST BE DESTROYED OR IT WILL DESTROY EVERY MONARCHY ON THE GLOBE.” (This is a typical example of the **Illutninati** double-talk. Monarchy really meant the moneylenders.)

Hazard Circular was concerned in all banking interests from overseas. It read, “Slavery is likely to be abolished by war power. This, I and my European friends are in favor of, because slavery is but the owning of labor, and carries with it the care of the laborers, while the European plan, led on by England, is that capital shall control labor by controlling wages.

“The great debt, that **Capitalists** will see is made out of the war, must be used to control the value of money. To accomplish this government we must use bonds, as a banking basis. We are now waiting for the Secretary of the Treasury of the United States to make that recommendation. It will not do to allow the so-called **Greenbacks**, to circulate as money for any length of time as we cannot control that. But we can control the bonds, and through them, the banking issues.”

The Bankers financed the election campaigns of enough Senators, and Congressmen, to assure them that the National Banking Act would become law. The National Banking Act did become law in 1863 despite the vigorous protests of President Lincoln. Thus, the International Bankers won another round. The people of the world had moved one-step nearer to economic, political and religious bondage.

On the letterhead of Rothschild's Brothers, Bankers, London, England, under date of 25 June 1863, they had written the following, "To **Messrs. Ikelheimer, Morton and VanderGould**, No. 3 Wall Street, New York, U.S.A.

Dear Sirs:

A **Mr. John Sherman** has written us from a town in Ohio, U.S.A., as to profits that we may make in the **National Banking** business, under a recent act of your **Congress**; a copy of this Act

accompanies this letter. Apparently, they had drawn this Act on the plan formulated by the **British Bankers Association**, and by that **Association** recommended to our **American friends**, as one that, if enacted into law, would prove highly profitable to the banking fraternity throughout the world.

Mr. **Sherman** declares that there has never been such an opportunity for capitalists to accumulate money as that presented by this act. It gives the **National Bank** almost complete control of the National finance. The few, who understand the system he says will either be so interested in its profits, or so dependent on its favors. There will be no opposition from that class, while on the other hand, the great body of the people, mentally incapable of comprehending the tremendous advantages that capital derives from the system, will bear its burden without complaint, and perhaps without even suspecting that the system is inimical to their interests ...

In reply to the above letter Messrs. **Ikelheimer, Morton** and **VanderGould** replied:

Dear Sirs:

We beg to acknowledge receipt of your letter of June 25, in which you refer to a communication received from Honorable **John Sherman**, of **Ohio**, with reference to the advantages, and profits, of an American investment under the provisions of the National Banking Act. Mr. Sherman possesses, in a marked degree, the distinguishing characteristics of a successful financier.

His temperament is such that whatever his feelings may be they never cause him to lose sight of the main chance. He is young, shrewd and ambitious. He has fixed his eyes upon the Presidency of the United States and already is a member of Congress (he has financial ambitions too). He rightfully thinks he has everything to gain by being friendly with men, and institutions, having large financial

resources. At the same time, they are not too particular in their methods, which are either obtaining government aid, or by protecting themselves against unfriendly legislation.

As to the organization of the **National Bank** here, and the nature and profits of such investments, we beg leave to refer to our printed circulars enclosed herein, viz.,

They are private corporations organized for private gain, and select their own officers and employees.

They are not subject to control of State Laws, except as Congress may from time to time provide.

They may receive deposits and loan the same for their own benefit. They can buy and sell bonds and discount paper and do general banking business.

To start a National Bank on the scale of \$1,000,000 will require purchase of that amount (par value) of U.S. Government Bonds. Purchase of U.S. Bonds now at 50 per cent discount, so that People can start a bank of \$1,000,000 capital at this time for only \$500,000. Deposition of these bonds must be with the **United States Treasury** at Washington, as security for the National Bank that the government will furnish currency to the bank.

The **United States Government** will pay 6 per cent interest on all bonds in gold, payment of the interest semi-annually. It will appear that at the present price of bonds the interest paid by the government itself is 12 per cent in gold on all money invested.

The United States Government on having the bonds aforesaid deposited with the Treasurer, on the strength of such security will furnish National currency to the bank depositing the bonds, at an annual interest of only one per cent per annum.

The demand for money is so great that this money can be readily loaned to the people across the counter of the Bank at a discount at the rate of 10 per cent at thirty or sixty days time, making it about 12 per cent interest on the currency.

The interest on the bonds, plus the interest on the currency, which the bond secures, plus the incidentals of the business, ought to make the gross earnings of the bank amount to from 28% to 33.33%.

National Banks have a privilege to increase and contract their currency at will, and of course, can grant or withhold loans, as they may see fit. As the banks have a National organization and can easily act together in withholding loans or extending them, it follows that they can by united action in refusing to make loans cause stringency in the money market, and in a single week or even a single day cause a decline in all products of the country.

National Banks pay no taxes on their bonds, on their capital, or on their deposits.

Following the exchange of the above letters, the **American Bankers** put into practice once again the manipulations mentioned. They reaped another rich harvest by foreclosures on property and securities left with them as security for loans, which their clients could not repay because the Bankers, acting in unity, withdrew currency, and restricted credits, to a degree that made it impossible for the vast majority of borrowers to meet their financial obligations.

Abraham Lincoln felt that after this sad, and costly, experience the **American** people might be ready to listen to sense so, once again, he launched a public attack upon the bankers.

Thierry Meyssan presents a conspiracy theory challenging the official account of events of the September 11 terrorist attacks. He contends that a missile launched by the American military, not a Boeing 757 hit the pentagon.

DETAILS-AMBIGUITY –QUESTIONS

"THE PLANE THAT HIT THE PENTAGON"

The **Pentagon** is the building of the **Defense Department**. It is the hugest office building in the world. It receives Twenty-three thousand employees and visitors daily. Its area is 16,000sq.m, It is called the pentagon because of its architectural design has five angles. It comprises five units united in one center and each of which is pentagon in shape. The height of its facades does not exceed 24 meters.

Of course, this sensitive building in the greatest nation the **United States of America, which** allays expects to attacks against it, has an extremely advanced protection system in the speed of response to threats, especially against air attacks by rockets or warplanes. As for the Boeing plain which they said Arab Muslim terrorists had led and hit the pentagon building with it, was a commercial plane Boeing 200 – 757 with a capacity 293 passengers., according to Boeing Factory specifications. It is 47.32 m long and 36.05 m in wide. When this pale is fully loaded, it weighs 115 tons and flies at a maximum speed of 900 kilometer per hour.

They said the plane hit the pentagon facade, which as we have mentioned earlier, does not exceed 24 meters, whereas the plane is 13 meters high when it lowers its wheels. The plane hit an empty building, which was under renovation and only 125 persons were killed most of them from the civilians working there at the time.

We may ask with **Thierry Meyssan**," How can a civilian plane of such a huge size get down to such an impossible low level to hit wall without even destroying a single lamp post or without harming the beautiful grass space or the wall or the car park or even the mini helicopter landing spot? !

However the more dangerous question is," How can a civilian plane, the height of which is 13 meters about the height of a three-storey building hit only the ground storey and 1st storey of the Pentagon building? Was it not more damaging to hit the roof of the pentagon building which accommodates 23000 individuals?

It is sure that any sensible man who has the minimum logical thinking will not accept this claim, which addresses the ignorant and the foolish.

Thierry Meyssan wanders, "How a plane of that size and with such a wide wing span makes a crack on the building which is at least 50% smaller than the size of the plane. In other words, how is it possible that the wings and the motors did not touch the building? Or how a plane of that size and characteristics gets into the most heavily guarded air space of the USA and no single civil or military radar cares to wonder what it is doing there."

It was supposed to see the body of the plane and its wings outside on the grass space. If the head of the plane, which melts quickly whereas its wings where the fuel tanks are combustible, then after the body of the Boeing gets burned it leaves burned debris

When one examines the photographs of the façade, taken in the minutes following the attack (even before the Arlington civilian fire fighters had time to deploy), one sees no trace of the right wing on fire in front of the façade, nor any hole in the façade into which the plane could disappear.

Responding to journalists during a press conference at the Pentagon, **Eddy Bloggard** fire chief claimed that "no voluminous debris from the aircraft" had remained, "nor any piece of the fuselage, nor anything of that sort". He declared that neither he nor his men knew what had become of the aircraft.

Apparently, without the least fear of laying itself open to ridicule, the Defence Department declared that the jet engines, made out of tempered steel, had disintegrated under the shock of the impact – without damaging the façade. The aluminums of the fuselage is claimed to have combusted at more than 2,500° Celsius within the building and to have been transformed into gas, but the bodies of the passengers which it contained were so little burned that they were later identified from their finger prints.

According to the Defence Department, a Boeing 757, all trace of which had been lost somewhere over Ohio, flew some 500 kilometres undetected. Then entered Pentagon air space, descended on to the lawn surrounding the heliport, bounced off the lawn, broke a wing in collision with an electric transformer station, hit the façade at the level of the ground floor and first story, and was totally consumed by fire, leaving no other traces than two dysfunctional black boxes and pieces of passengers' bodies. What a big lie!

It is obviously impossible that a Boeing 757, could, fly some 500 kilometres, escape detection by civil and military radar, by fighter-bomber planes sent in pursuit of it and by observation satellites that they had just activated.

It is also obviously impossible that a Boeing 757 could enter the Pentagon's air space without destroying by one or more of the five missile batteries protecting the building.

Close examination of the official photographs of the scene of the attack, taken and published by the Defence Department, shows that no part of the Pentagon bears any mark of an impact that could be attributed to the crash of a Boeing 757.that the attack, against the Pentagon on 11 September, killing 125 persons , was by a jet airliner.

The scene of the attack was thoroughly disturbed on the following day by the immediate launch of new construction work, with the result that many of the elements necessary to reconstruct what had happened are missing. The elements that do remain, however, converge in a single hypothesis that it is not possible to prove with certainty.

So what was the cause of the explosion, which targeted the Pentagon? What had happened to American Flight 77? Were its passengers killed, in this case, who killed them, and why? In case they were alive, where are they now?

Many questions necessitate answers from the American Administration but we have to ask what the official story of the events is trying to hide?

Immediately after the attacks General Wesley Clark former NATO Commander during the war on Kosovo in an interview with CNN said," We had foreknowledge since some time that some groups were planning an attack on the Pentagon but we did not have enough information to act upon."

This ambiguous statement did not refer to a foreign aggressor but to threats, which did extremist right wing militia against the Pentagon make. This statement alludes to the secret confrontations inside the American leadership.

September 15, 2001: **Egyptian President Husni Mubarak** in an interview with **CNN** raises questions about who was behind the 9/11 attacks, in particular questioning whether the alleged perpetrators had the necessary flying skills to carry out the attacks. "The Pentagon is not very high, a pilot could come straight to the Pentagon like this to hit, and he should have flown a lot in this area to know the obstacles which could meet him when he is flying very low with a big commercial plane to hit the Pentagon in a special place." He adds, "Somebody has studied this very well, someone has flown in this area very much." When asked, "Are you suggesting it was an inside operation?" he replies, "Frankly speaking, I don't want to jump to conclusions."

"I find it hard to believe that people who were learning to fly in Florida could, within a year and a half, fly large commercial airlines and hit with accuracy the towers of the World Trade Center which would appear, to the pilot from the air, the size of a pencil. Only a professional pilot could carry out this mission, not someone who learned to fly for 18 months in Florida." Mubarak also later claims that Egyptian intelligence had warned American officials 12 days before 9/11 that al-Qaeda was in the advance stages of conducting a significant operation against a US target. Egypt's President Mubarak described the attacks as "ugly." (40) He added in a CNN interview "the Egyptian people share a sense of grief" over the attacks and claimed that Egypt was cooperating in sharing information that might help. However, when asked in an interview with United Press International, "What motives lie behind the kind of all-consuming hatred of the United States demonstrated by such acts of barbarism?" Even Mubarak, a close American ally and major beneficiary of U.S. foreign aid--hinted that America's "faulted" policy was the source:

In the first minutes following the first attack on the World Trade Center, officials suggested to the media that the person behind the attacks was Osama bin Laden, the epitome of Muslim fanaticism. Not long after, the recently appointed director of the FBI, Robert Mueller III designated nineteen kamikazes by name and mobilized all the means at the disposal of his agency to track down their accomplices. The FBI thus never undertook any investigation but, instead, organized a manhunt, which, in the eyes much of the United States public, quickly took on the appearance of an Arab

hunt. This reached such a pitch they incited people to attack – even kill – Arabs whom they naively considered collectively responsible for the attacks.

If we analyze the attacks of September 11, we notice first off that there was much more to them than the official version acknowledges.

.The official version does not include the attack on the White House annex; the Old Executive Office Building (called the "Eisenhower Building"). Yet, on the morning of the eleventh, ABC television broadcast, live, pictures of a fire ravaging the presidential services building , neither does the official version takes into account the collapse of a third building in Manhattan World Trade Center complex, independently of the twin towers. A plane did not hit this third building. However, a fire, too, ravaged it, before collapsing for an unknown reason. This building contained the world's biggest secret CIA operations base, where the Agency engaged in economic intelligence gathering that the military-industrial lobby considered a waste of resources that should have been devoted to strategic intelligence gathering.

To give credence to the fable of Islamic terrorists, the United States authorities invented kamikazes.

Although it would have been possible for a well-organized group of persons to bring firearms into commercial airliners, the kamikazes apparently used cardboard cutters as their only weapons. They said the kamikazes had learned to pilot Boeing 757s and 767s in the space of several hours of simulator training, becoming better pilots than professionals do. This mastery allowed them to carry out complex in-flight approach manoeuvres.

The Justice Department has never explained how it established the list of the kamikazes. The airline companies have furnished the exact number of passengers in each plane, and the passenger lists, incomplete, do not mention the persons who boarded at the last minute. In checking the these lists, one notices that names of the kamikazes are not on them and that only three passengers are not identified for flight 11 and only two for flight 93. It is thus impossible that 19 kamikazes boarded. Further, several of those listed as kamikazes have turned up, alive. The FBI nonetheless maintains

that it had definitively identified all the hijackers and that the complementary information, such as birth dates, makes it improbable to confuse them with persons of the same name. For those who might doubt this, the FBI has a ridiculous proof: whereas the planes burned and the twin towers collapsed, the passport of **Mohammed Atta** was miraculously intact on the smoking ruins of the World Trade Center.

Several passengers confirmed by telephone calls made to members of their families, the existence of hijackers whether these or others. Unfortunately, these conversations are known to us only by hearsay and have not been published, even in the case of those that were recorded. The Global Hawk technology, developed by the Air Force, makes it possible to take control of a commercial airliner regardless of the intentions of its pilot(s) and to direct it by remote control.

In view of the elements that I have just presented, it appears that the attacks of September can not be attributed to foreign terrorists from the Arab-Muslim world – even if some of those involved might have been Muslim – but to United States terrorists.

New York Times had revealed that there was a secret military base inside the International Trade Center. It was a base for CIA. Tens of Thousands people working in these towers were human shields for this military base. The real surprise, however, was the number of victims. By all calculations, it should be not less than 4080, yet according to official figures issued on 9 February 2001 the gross total number of victims was 2843 including the victims of the passengers of the two planes, crew, police and firefighters killed in the collapse of the two towers.

This is a very low number of the total victims. It indicates that arrangements intended to minimize as much as possible the number of victims for carrying out these attacks comparing with the initial estimations by American information media. Later, however we discover that some people working in the upper floors of the two towers had taken absent leaves on that particular day of the attacks

Haaretz the Israeli daily, had revealed that **Odigo** a leading company in the realm of electronic letters had received from unknown source cautioning of attacks on New York two hours before the attacks. The company manager Moesha Malkofer had confirmed this fact to the newspaper

Thus, they had warned all who were working in the upper floors of the north tower, although probably not all of them took it seriously.

Thierry Meyssan gives an example of this type of events perpetrated by suspicious parties, which have private interests and malignant objectives. Such as the Oklahoma City bombing, which occurred on April 19, 1995, when American militia movement sympathizer Timothy **McVeigh**, with the assistance of Terry Nichols, destroyed the Alfred P. Murrah Federal Building in downtown Oklahoma City, Oklahoma. On that day, many who were working in the building had taken sick

leaves, so the explosion killed only 168 persons. McVeigh belonged to rightist organization, which **FBI** had infiltrated.

President Bush said on 4 December 2001 while attending day of celebration in an American school, that he saw the scenes of the attack on the North tower first on a closed circuit, and then Mr. Andy Card told him about the second attack.

This is the dialog:

QUESTION: One thing, Mr. President, is that you have no idea how much you have done for this country, and another thing is that how did you feel when you heard about the terrorist attack?

BUSH: Well .Thank you, Jordan.

Well, Jordan (you are not going to believe what state I was in when I heard about the terrorist attack. I was in Florida. In addition, my chief of staff, Andy Card -- actually, I was in a classroom talking about a reading program that works. In addition, I was sitting outside the classroom waiting to go in, and I saw an airplane hit the tower -- the TV was obviously on, and I use to fly myself, and I said, "There's one terrible pilot." And I said, "It must have been a horrible accident."

However, I was whisked off there -- I did not have much time to think about it, and I was sitting in the classroom, and Andy Card, my chief who was sitting over here walked in and said, "A second plane has hit the tower. America's under attack."

There is a problem with the above statement. There was no live video coverage of the first plane hitting the tower. There could not be. Video of that first plane hitting the tower did not surface until days later.

Bush is lying through his teeth here.

In addition, we must remember that even after Andy informed Bush of the second impact, and by his own admission, Bush knew America was under attack, yet, he continued to read to the classroom full of children.

If the CIA was able to make a video then it means it had prior knowledge of the attack and did not do anything to prevent it.

Even the passengers' lists published by the Airlines companies on 12 September 2001 had not included the names of these persons.

Stocks of Morgan Stanley, which occupies 22 floors of the International Trade Center, had witnessed similar plummeting in their price. Merrill Lynch & Co the First leading international stock commission had suffered similar plummeting in the price of its stocks.

Thierry Meyssan had not forgotten to point out to what Deutsche Bank and its independent American branch "Alex Brown had achieved. **A. B. Crongard** was the manager of Alex Brown, until 1998. Later he had become Director of CIA since 26 March 2001.

The strange thing says **Meyssan** when the FBI reached to Alex Brown it could not proceed in its investigation. "IOSCO had opened its investigation but could not solve the enigma, although it is easy to trace the movement of capitals because deals between banks are documented by two devices specialized for this purpose. They should have revealed the Banking secrecy and identified the beneficiaries from 11 September attacks. However, that had not happened. The FBI had not bothered to get the owners names of the cautioning Websites.
